On January 3, 2024, PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) filed its Fourth Supplement to Advice 23-015. In that filing, PacifiCorp proposed to decrease the amount recovered through Schedule 190 from approximately \$47.37 million requested in its September 28, 2023 filing to approximately \$46.50 million based on an agreement reached with Staff. Although the Company does not believe that a Less than Statutory Notice Application is necessary under ORS 757.220, as this is an existing advice letter that was filed in June of 2023, PacifiCorp is filing this application at the request of Staff.
