> RE: Second Supplement to Oregon Advice No. 16-09 Revisions to Rule F – Service Connection and Discontinuance Revisions to Schedule 66 – Miscellaneous Charges

Attention Filing Center:

On May 6, 2016, Idaho Power Company ("Company") filed proposed changes to Rule F and Schedule 66 tariff sheets. A supplemental filing was made on May 25, 2016, changing the requested effective date per the Public Utility Commission of Oregon Staff's ("Commission Staff") request.

The Company is now making a second supplemental filing based on an agreement reached on June 22, 2016, with Commission Staff to increase the amount of the proposed remote service connection charge in Schedule 66 from \$13.00 to \$20.00.

Enclosed is a revised Tariff Sheet No. 66-3 reflecting the above-mentioned revision and because this supplemental filing is not within 30 days of the requested effective date of July 6, 2016, an L.S.N. is also enclosed.
