RE: Supplement to Idaho Power Company's Tariff Advice No. 17-04

Schedule 92, Boardman Operating Life Adjustment

Attention Filing Center:

On March 17, 2017, Idaho Power Company ("Idaho Power" or "Company") filed Advice No. 17-04, revisions to Schedule 92, Boardman Operating Life Adjustment, pursuant to the Public Utility Commission of Oregon ("Commission") Order No. 12-235 with a requested effective date of June 1, 2017.

Subsequent to the Company's filing, Commission Staff expressed concern about the true-up component of Idaho Power's revenue requirement computation with respect to an automatic adjustment clause. To eliminate Staff's concern and promote consistency among similar automatic adjustment clauses, Staff requested the Company file a supplement to Advice No. 17-04.

Therefore, the Company proposes to remove the true-up component of the revenue requirement computation and add language indicating Schedule 92 is an automatic adjustment clause as defined by ORS 757.210(1). Removal of the true-up component reduces the reduction to customer rates from the Company's initial proposal of (\$7,738) to (\$5,212), resulting in an overall incremental revenue requirement of \$102,011. Using an updated sales forecast for the June 1, 2017, to May 31, 2018, this equates to an overall decrease of \$880 or 0.002 percent.

Enclosed is a revised Tariff Sheet No. 92-1 reflecting the above-mentioned revision and because this supplemental filing is not within 30 days of the requested effective date of June 1, 2017, an L.S.N. is also enclosed.
