**2.10 Unexpected Event.**

2.10.1 CenturyLink and Customer acknowledge the possibility that an Unexpected Event (as defined below) may occur during the Term of this Agreement. For purposes of this Agreement, an "Unexpected Event" means an unforeseen event that results in a reduction of Customer's total Monthly Recurring Charges incurred by Customer under this Agreement. An Unexpected Event will be limited to the following event:

(a) the introduction by CenturyLink of a new service that is based on substantially new technology that was unavailable as of the Effective Date and that materially improves Customer's current Services and/or applications by affording more efficient communication through an increase in the speed and/or capacity of such communication or Service and thereby decreased demand for Customer's existing Service.

2.10.2 Customer must promptly notify CenturyLink upon the occurrence of any Unexpected Event. Following the receipt of notice and confirmation by CenturyLink of the conditions giving rise to the application of this provision the parties will meet in order to develop another mutually agreeable solution, including, but not limited to, revised pricing, term length, or other terms based on Customer's revised, actual Monthly Recurring Charges, and in all cases, the solution will include without limitation, Customer's payment of any charges incurred by CenturyLink from a third party provider as a result of the Unexpected Event. This provision does not constitute a waiver of any charges incurred by Customer prior to the time the parties mutually agree to amend or supersede this Agreement.

3. **Billing Information.** Any new pricing applicable to Customer's existing Services, if any, will become effective at CenturyLink QCC's earliest opportunity, but in no event later than the second full billing cycle following the Amendment Effective Date ("Billing Change Date"). The new pricing is otherwise in lieu of, and supersedes and replaces in its entirety, the pricing that Customer previously received under the Agreement.

5. **Effective Date.** This Amendment will be effective as of the date it is executed by CenturyLink after the Customer's signature (the "Amendment Effective Date") and will become part of the Agreement. All other terms and conditions in the Agreement will remain in full force and effect and be binding upon the parties. This Amendment and the Agreement set forth the entire understanding between the parties as to the subject matter, and in the event there are any inconsistencies between the two documents, the terms of this Amendment will control.

CLVP provides discounted rates on Discount Eligible Services based on Customer's purchase of 10 to 3,000 Contributory Access Lines, as more fully described herein. CenturyLink provides CLVP in accordance with the applicable CenturyLink tariff, price list, price schedule, administrative guideline, catalog, or other rate and term schedules ("Tariff"), which is incorporated into this Acknowledgment by reference and made a part of this Acknowledgment. The Contributory Access Lines and Discount Eligible Services (collectively the "Service") described herein are provided in accordance with, and governed by the Tariff applicable to the Service. CenturyLink reserves the right to amend, change, withdraw, or file additional Tariffs in its sole discretion, with such updated Tariffs effective upon posting or fulfillment of any necessary regulatory requirements. This offer may not be provided in conjunction with any other local voice volume discount plan.

"the 14 States" are Arizona, Colorado, Idaho, Iowa, Minnesota, Montana, Nebraska, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming.

"Contributory Access Lines" means the aggregate number of Customer's existing and new local business exchange access lines as set forth on Exhibit 2, that will be considered for purposes of determining the applicable Line Tier as set forth in Exhibit 1, both of which are incorporated by this reference and made part of this Acknowledgment. "Rates" means the net rates that will be derived by applying discounts to the Tariff month-to-month rates for Discount Eligible Services which will appear as a credit on each monthly bill.

2. **Term.** This Acknowledgment will expire three years from the Discount Effective Date ("Term"). If CenturyLink continues to provide Service after the Term without a further agreement, the CLVP Rates will be discontinued and Service will continue at the then applicable month-to-month rate and terms and conditions of the Tariff.

3. **Contributory Access Lines, Line Tier and Rates.** Based on 222 Contributory Access Lines, Customer will pay the Rates for Services listed on Exhibit 1 hereto for the 50-499 line tier ("Line Tier") on each monthly bill for all Discount Eligible Services purchased during the Term. This provision is not intended to deprive a small claims court or state agency of lawful jurisdiction that would otherwise exist over a claim or controversy between the parties.

**7.2 Waiver of Jury Trial and Class Action.** Each party, to the extent permitted by law, knowingly, voluntarily, and intentionally waives its right to a jury trial and any right to pursue any claim or action relating to this Acknowledgment on a class or consolidated basis or in a representative capacity. If for any reason the jury trial waiver is held to be unenforceable, the parties agree to binding arbitration for any dispute relating to this Acknowledgment under the Federal Arbitration Act, 9 U.S.C. § 1, et. seq. The arbitration will be conducted in accordance with the JAMS Comprehensive Arbitration Rules. Judgment upon the arbitration award may be entered in any court having jurisdiction.

**7.3 Limitations Period.** Any claim relating to this Acknowledgment must be brought within two years after the claim arises.

**8. ARRA.** Customer will not pay for Service with funds obtained through the American Recovery and Reinvestment Act or other similar stimulus grants or loans that would obligate CenturyLink to provide certain information or perform certain functions unless each of those obligations are explicitly identified and agreed to by the parties in this Acknowledgment or in an amendment to this Acknowledgment.

**9. HIPAA.** CenturyLink does not require or intend to access Customer data in its performance hereunder, including but not limited to any confidential health related information of Customer's clients, which may include group health plans, that constitutes Protected Health Information ("PHI"), as defined in 45 C.F.R. §160.103 under the Health Insurance Portability and Accountability Act of 1996 ("HIPAA Rules"). To the extent that any exposure to PHI is incidental to CenturyLink's provision of Service and not meant for the purpose of accessing, managing the PHI or creating or manipulating the PHI, such exposure is allowable under 45 CFR 164.502(a)(1)(iii).

**10. Confidentiality.** Neither party will, without the prior written consent of the other party: (a) disclose any of the terms of this Acknowledgment; or (b) disclose or use (except as expressly permitted by, or required to achieve the purposes of, this Acknowledgment) the Confidential Information of the other party. **ADDENDUM  
TO THE CENTURYLINK AGREEMENT FOR ISDN PRI ("Service")**

This is an addendum ("Addendum") to the agreement between Qwest Corporation d/b/a CenturyLink QC ("CenturyLink") and [REDACTED] ("Customer") under which Customer is purchasing CenturyLink's Service noted above (the "Agreement"). Except as set forth in this Addendum, capitalized terms will have the definitions assigned to them in the Agreement.

The purpose of this Addendum is to obtain agreement from CenturyLink Communications, LLC f/k/a Qwest Communications Company, LLC d/b/a CenturyLink QCC ("CenturyLink QCC"), that it will provide a credit under Customer's CenturyLink QCC account for the full or partial amount of the early termination charges resulting from the migration of CenturyLink's Service noted above, to a CenturyLink QCC IP-based service. To qualify for this credit, Customer must (a) sign a new agreement with CenturyLink QCC (or an amendment to an existing CenturyLink QCC agreement) for the new IP-based service, provided Customer does not already have such service under their CenturyLink QCC agreement; (b) submit an order for the new IP-based service with a sufficient term commitment for CenturyLink QCC to recover the credit; and (c) request the credit within 30 days of the termination of the Service.
