The tariff sheets reflected the rates resulting from Idaho Power's proposed increase in the Company's Oregon jurisdictional revenue requirement of \$139,462 requested as part of Idaho Power's application to institute revised depreciation rates, filed concurrently in docket UM 2180.

On November 19, 2021, the Public Utility Commission of Oregon Staff and Idaho Power filed a stipulation resolving all issues associated with the Company's request in docket UM 2180, agreeing to no increase in the Oregon jurisdictional revenue requirement and therefore no change in customer rates.
