ORDER

**DISPOSITION: STIPULATION ADOPTED**

On October 29, 2001, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of law. Defendant committed the violation described in this complaint within one year from the date a prior order was issued. A penalty shall be imposed in the amount of \$5,000 for each violation alleged, and the \$1,000 penalty that was suspended in order No. 01-108 issued against Defendant shall be reinstated, for a total penalty of \$6,000. On November 9, 2001, a copy of the complaint was served.

On November 14, 2001, the parties to this proceeding entered into a stipulation, which is attached and incorporated by reference.

Defendant admits committing the violation alleged in the complaint. The stipulation is adopted.

From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule(s) as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

**ORDER**

IT IS ORDERED that:

1. Civil monetary penalties shall be assessed against Defendant in the amount of \$6,000; and
2. Payment of the balance of the penalties (\$1,000) from order No. 01-108 issued against Defendant shall be reinstated; and
3. Defendant shall pay the sum of \$3,500, due and payable within 30 days from the date of service of this order; and
4. Payment of the balance of the penalties (\$2,500) shall be suspended for a period of one year following entry of this order; and
5. Complainant may reopen this proceeding and petition for imposition of all or a portion of the suspended penalties if Defendant has not complied with all OUNC rules for a period of one year following entry of this order.
