On October 15, 2002, Avion Water Company (Avion) filed an application with the Public Utility Commission (Commission) under ORS 757.415, seeking authority to borrow up to \$5,700,000 for the development of a variety of projects, predominantly for water mains to serve the Greater Avion System. The basis for the current request is detailed in Staff's recommendation memo, attached as Appendix A.

Based on a review of the application and the Commission's records, the Commission finds that this application satisfies applicable statutes and administrative rules. At its public meeting on November 5, 2002, the Commission adopted Staff's recommendation and approved Avion's current request.

ORDER

IT IS ORDERED THAT:

- 1. The application of Avion Water Company for authorization to borrow up to \$5,700,000, is granted.
- 2. Avion Water Company will provide a final Report of Capital Expenditures upon completion of construction.
- 3. The Report of Capital Expenditures will detail amounts received from developer advances and will reconcile with the refinanced balance.

STAFF RECOMMENDATION:

The Commission should approve Avion Water Company's (Avion or Company) application, granting authority to borrow up to \$5,700,000 for uses consistent with ORS 757.415. Approval should be granted subject to the following Condition:

The Company will provide a final Report of Capital Expenditures upon completion of construction. The report will also detail amounts received from developer advances and will reconcile with the refinanced balance.

DISCUSSION:

On October 15, 2002, Avion filed an application with the Commission to approve its financing for the development of a variety of projects, predominantly for water mains to serve the Greater Avion System. Avion provided a sufficient description of the proposed construction and indicated that the financing will be through a conventional bank loan. An outstanding balance will be refinanced at a lower rate and the new funds will provide financing for the anticipated construction, less an amount provided from Avion's capital reserves and net of developers' contributions. The loan's terms and rate appear favorable. The financing expenses associated with the loan are expected to be \$7,000, including appraisal and bank fees. This amount is reasonable.

For ratemaking purposes, the Commission reserves judgment on the reasonableness of the Company's capital costs, capital structure and the commissions and expenses incurred for security issuances. In its next rate proceeding, the Company will be required to show that its capital costs and structure are just and reasonable.

PROPOSED COMMISSION MOTION:

Consistent with the terms and conditions of the Company's application, Avion's application for authority to finance \$5,700,000 is approved with Staff's Condition.
