DISPOSITION: MOTION GRANTED; IMPLEMENTATION OF SEPARATE NONRECURRING CHARGE FOR MANUALLY-SUBMITTED UNBUNDLED NETWORK ELEMENT SERVICE ORDERS WAIVED

On November 13, 1998, the Public Utility Commission of Oregon (Commission) entered Order No. 98-444 in Phase I of this docket. That order requires, *inter alia*, that Qwest Corporation (Qwest) develop separate nonrecurring charges (NRCs) for electronic- and manually-submitted service orders for unbundled network elements (UNEs). The purpose of the manual NRC is to compensate Qwest for additional costs incurred to process non-electronic UNE service orders submitted by competitive local exchange carriers (CLECs).

On June 5, 2003, Qwest filed a motion to waive the requirement that it implement a NRC for manually-submitted UNE service orders. Qwest states that the requirement is not cost effective at the present time, given that (1) it requires the company to expend significant capital and human resources to reprogram its billing systems, and (2) more than 99 percent of all UNE orders are now submitted electronically. Qwest emphasizes that CLECs are not prejudiced by the waiver, since Qwest will charge the lower electronic NRC even when manual orders are submitted. Qwest requests the opportunity to reinstitute the manual NRC in the future should current circumstances change.

On June 12, 2003, a telephone conference was held to discuss Qwest's motion. None of the participating in the conference objected to the motion. The Commission finds that proposed waiver is reasonable and should be granted.

ORDER

IT IS ORDERED that the motion by Qwest Corporation to waive that portion of Order No. 98-444 requiring implementation of a separate nonrecurring charge for manually-submitted unbundled network element orders is granted. Qwest may request authority to reinstitute the charge at a future date.
