DISPOSITION: STIPULATION ADOPTED

On June 27, 2003, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of law and requested a penalty of \$1,000. On July 1, 2003, a copy of the complaint was served.

On July 3, 2003, the parties to this proceeding entered into a stipulation, which is attached as Appendix A.

Defendant admits committing the violation alleged in the complaint. The stipulation is adopted.

From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule(s) as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. Civil monetary penalties shall be assessed against Defendant in the amount of \$1,000 for one violation(s) of law.
- 2. Defendant shall pay the sum of \$200, due and payable within 30 days from the date of service of this order.
- 3. Payment of the balance of the penalties (\$800) shall be suspended, unless Defendant fails to comply with paragraph 2 above or a showing is made that Defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.
- 4. If Defendant has not paid the amount assessed in paragraph 2 above within 30 days from the date of service of this order, then Defendant shall pay the amount assessed in paragraph 1 above (\$1,000). Such payment shall be due immediately following the expiration of the time period set out in paragraph 2 above.
- 5. Within 30 days following entry of this order, defendant shall contact the OUNC Speakers Bureau and attend a training session on Oregon excavation laws.
