DISPOSITION: AGREEMENT APPROVED

On August 27, 2003, Northwest Open Access Network and Qwest Corporation filed a negotiated interconnection agreement with the Public Utility Commission of Oregon (Commission). The parties seek approval of this agreement under Section 252(e) of the Telecommunications Act of 1996. The Commission provided notice by posting an electronic copy of the agreement on the World Wide Web, at: http://www.puc.state.or.us/caragmnt/. Only the Commission Staff (Staff) filed comments.

Under the Act, the Commission must approve or reject an agreement reached through voluntary negotiation within 90 days of filing. The Commission may reject an agreement only if it finds that:

- (1) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
- (2) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity.

Staff noted that an interconnection agreement or amendment thereto has no effect or force until approved by a state Commission. *See* 47 U.S.C. Sections 252 (a) and (e). Accordingly, the effective date of this filing will be the date the Commission signs an order approving it, and any provision stating that the parties' agreement is effective prior to that date is not enforceable.

The parties stated the agreement is a Statement of Generally Accepted Terms (SGAT). The terms and conditions of the agreement may be similar to the SGAT currently under review; however, at this time there is no approved SGAT on file with the Commission. As such, the agreement has been processed as a negotiated agreement.

Staff recommended approval of the agreement. Staff also cautioned all parties to interconnection agreements to file agreements immediately after final signature and within a reasonable time period relative to the stated effective date. Staff concluded that the agreement does not appear to discriminate against telecommunications carriers who are not parties to the agreement and does not appear to be inconsistent with the public interest, convenience, and necessity.

OPINION

The Commission adopts Staff's recommendation and concludes that there is no basis under the Act to reject the agreement. No participant in the proceeding has requested that the agreement be rejected or has presented any reason for rejection. Accordingly, the agreement should be approved.

CONCLUSIONS

- 1. There is no basis for finding that the agreement discriminates against any telecommunications carrier not a party to the agreement.
- 2. There is no basis for finding that implementation of the agreement is not consistent with the public interest, convenience, and necessity.
- 3. The agreement should be approved.

ORDER

IT IS ORDERED that the agreement, band Qwest Corporation, is approved.	between Northwest Open Access Network
