DISPOSITION: ORDER NO. 03-750 RESCINDED; STIPULATION ADOPTED

On September 30, 2003, the Public Utility Commission of Oregon (Commission) filed a complaint against Defendant. The complaint charged Defendant with one violation of law and requested a penalty of \$1,000. On October 14, 2003, a copy of the complaint was served. Defendant failed to file an answer or otherwise plead or appear within the 20 days after service of the complaint and on December 17, 2003, the Commission entered a default order, Order No. 03-750, and assessed monetary penalties against Defendant

On December 31, 2003, the Defendant filed an executed Stipulation together with a Cashier's check in the amount of \$200. Defendant admits committing the violation alleged in the complaint.

In this instance, Defendant did not sign and return the Stipulation at the appropriate time. However, he believed that an agreement had been reached, and he had begun satisfaction of the Stipulation by filing the executed Stipulation and delivering a \$200 Cashier's check to the Commission. He is also prepared to complete the terms of the Stipulation by scheduling his attendance in an awareness class.

The Commission acknowledges payment and adopts the Stipulation entered into by the parties to this proceeding, which is attached as Appendix A. Under the circumstances, Order No. 03-750 should be rescinded pursuant to ORS 756.568. We further order Defendant to complete the unsatisfied terms of the stipulation by attending a training session on Oregon excavation laws with the Oregon Utility Notification Center Speakers Bureau, as specified in Paragraph 4C. of the Stipulation.

ORDER

IT IS ORDERED that:

- 1. Civil monetary penalties shall be assessed against Defendant in the amount of \$1,000 for one violation of law. Pursuant to the Stipulation, Defendant has paid the sum of \$200.
- 2. Defendant must complete the unsatisfied terms of the Stipulation by attending a training session on Oregon excavation laws with the Oregon Utility Notification Center Speakers Bureau, as specified in Paragraph 4C. of the Stipulation.
- 3. Payment of the balance of the penalties (\$800) shall be suspended, unless Defendant fails to comply with paragraph 2 above or a showing is made that Defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.
