DISPOSITION: APPLICATION APPROVED WITH CONDITIONS

On April 1, 2004, Westland Estates Water System filed an application with the Public Utility Commission of Oregon (Commission) pursuant to ORS 757.480 and OAR 860-036-0715, requesting approval to transfer the corporation and utility property of Westland Estates Water System, Inc. to Stephen F. Gass.

Based on a review of the application and the Commission's records, the Commission finds that the application satisfies applicable statutes and administrative rules. At its Public Meeting on May 4, 2004, the Commission adopted Staff's recommendation to approve the requested transfer as proposed. Staff's recommendation is attached as Appendix A and is incorporated by reference.

OPINION

Under ORS 757.480, any water utility doing business in Oregon shall first obtain Commission approval for any transaction to sell, lease, assign or otherwise dispose of property.

OAR 860-036-0715 specifies the information regarding applications for authority to sell, lease, assign, mortgage, merge, consolidate, terminate, abandon or otherwise dispose of or encumber property. This application contains the necessary information to transfer the utility property.

Confirmation of customer notification was received as a part of this application.

Staff investigated the following issues:

<u>Public Interest Compliance</u>: Utility operations will be maintained under the existing operational team in that a qualified certified operator must manage the system.

<u>Records Availability, Audit Provisions and Reporting Requirements</u>: The proposed ordering condition No. 1 provides the necessary access to Westland's books and records.

With the previously listed conditions, this transfer appears to be fair, reasonable, and not contrary to the public interest.
