DISPOSITION: SOUTHERN OREGON EXTENDED AREA SERVICE REGION ESTABLISHED; TARIFFS APPROVED

In this order, the Commission approves the creation of a unified toll-free calling area in Southern Oregon. The new Extended Area Service (EAS) Region includes 18 exchanges served by four telephone companies, as shown by the map at Appendix A. Toll-free calling in the Southern Oregon EAS Region will be available no later than October 2, 2004.

To analyze the merits of the EAS Region, the Commission followed the procedures outlined in Order No. 89-815: first determine demand and the community of interest, then analyze the proposed tariffs, and finally, decide whether the proposed EAS service is in the public interest. In Phase I, the Commission found that a community of interest exists among these exchanges. *See* Order No. 03-148. In Phase II, the Commission solicited public input and analyzed the proposed tariffs and the effect on consumers. After consideration, the tariffs are approved, subject to the terms of this order, and the proposed EAS Region is found to be in the public interest.

PHASE I – COMMUNITY OF INTEREST DETERMINATION

The Commission has long recognized the problem of out-dated telephone exchange boundaries. To address this problem, the Commission allows telephone customers to request EAS to other nearby exchanges to increase their toll-free calling area. However, EAS is not cost-free; it merely changes the way telephone companies are compensated for interexchange telephone service. To balance whether the benefits of

EAS service outweigh the costs, the Commission establishes whether a community of interest exists among the exchanges in the first phase.

To determine whether a community of interest exists among exchanges, the Commission examines whether "there is a social, economic, or political interdependence between two areas or where there is a heavy dependence by one area on another area for services and facilities necessary to meet many of its basic needs." *See* UM 116, Order No. 87-309 at 8. In this examination, the Commission created an Advisory Task Force on a Southern Oregon EAS Region to analyze the extent to which the exchanges share business, social, governmental, educational, medical, and other links. The Task Force recommended that eighteen exchanges be included in the Southern Oregon EAS Region, attached as Appendix A. The Commission adopted that recommendation. *See* Order No. 03-148.

PHASE II – TARIFF ANALYSIS

After Phase I was completed, the Commission analyzed the proposed company tariffs in Phase II of the EAS process. Four different local exchange carriers (LECs) provide service to the exchanges in the proposed Southern Oregon EAS Region. Citizens Telecommunications Company (Citizens) serves the Glendale, Wolf Creek, Selma, Cave Junction, and O'Brien exchanges; United Telephone Company of the Northwest dba Sprint (Sprint) serves the Prospect, Shady Cove, Butte Falls, and White City exchanges; Verizon Northwest Inc. (Verizon) serves the Murphy-Provolt exchange; and Qwest Corporation (Qwest) serves the Ashland, Grants Pass, Rogue River, Gold Hill, Central Point, Medford, Jacksonville, and Phoenix-Talent exchanges. Each LEC proposed tariffs to provide the EAS routes under consideration.

Customer Notification and Public Hearings

Customers in every affected exchange were notified by the LECs of a series of seven open house meetings held in the evenings from December 1 through December 11, 2003 to explain the proposed EAS routes and gauge customer sentiment. The meetings were held in Medford, Grants Pass, Wolf Creek, Cave Junction, Applegate, Shady Cove, and Eagle Point. Those locations represent exchanges in each of the four LEC service areas. Commission Staff, representatives from the affected LEC, and members of the Task Force participated in each open house meeting. At those meetings, customers could comment by writing down their remarks on a card or by speaking to a court reporter.

Of the comment cards, four opposed the Region, three asked questions, and 90 supported the inclusion of their exchange in the EAS Region. Those who were opposed lived in the Sprint or Citizens exchanges and were concerned that they had to pay higher rates than those who lived in exchanges served by other telephone companies. Many of the positive responses indicated that they would save money due to reduced long

distance charges, that it would enhance business prospects, and that the proposal was "long overdue."

Sprint customers in the Prospect, Shady Cove, Butte Falls, and White City exchanges were also balloted because their increase in rates was much higher than in other exchanges. The initial ballots appeared to present a choice between the increased rates for joining the Region or their current rates for staying out of the Region. Customers in Shady Cove, Butte Falls, and White City opted to join the Region, but customers in Prospect did not. Then, Sprint proposed changing its method of calculating EAS charges to a matrix system resembling those used by other telephone companies, which would have dramatically changed the rates for those exchanges even if they stayed out of the Region. After due consideration, the Commission approved Sprint's new matrix. *See* Order No. 04-093. With the new rate information, customers in Prospect were balloted again and supported joining the Region. *See* Order No. 04-217 at 6.

In addition, dozens of letters sent to the Commission were tallied. E-mails sent to the Commission and the Task Force were also included in the written record, as were notes from telephone calls made to the Commission. Most of the letters, e-mails, and phone calls supported including every exchange in the Region. A few felt that increased EAS access was not necessary at any price, but many saw it as an improvement. Business owners wrote to say that it would increase the area from which they could seek customers, and residential customers commented on the benefits of local calling to nearby neighbors who are on the other side of an exchange boundary. Based on the support from each exchange for participating in the Region, all 18 exchanges were included in the Region. *See* Order No. 04-217.

Stipulations

Staff reviewed the telephone companies' proposed tariffs and after conducting discovery and exchanging information, entered into a stipulation with each company. No party filed an objection to the stipulations, which are set forth in Appendices B through E. The stipulated EAS rates for each of the four LECs are set out in Appendices F through I.

Rate Design Criteria

In the generic EAS docket, UM 189, the Commission adopted ten rate design criteria for EAS conversion. The stipulated rates for each LEC meet those criteria by containing the following features:

EAS Criterion 1: Flat EAS rates must be available for all EAS routes.

The stipulated EAS rates for each LEC comply with Criterion 1. Each LEC has a flat rate available for all EAS routes, existing and proposed.

Criterion 2: A measured rate option must be available for all EAS routes.

The stipulated rates for each LEC comply with Criterion 2. The carriers have an existing measured rate option and have not proposed to change their measured EAS rates. All of the measured EAS rates proposed by the companies are consistent with measured rates charged by the other telecommunications utilities and with Commission guidelines.

<u>Criterion 3: A combination of flat local exchange service and measured EAS must be</u> offered.

The stipulated rates for each LEC comply with Criterion 3. Each carrier currently provides a combination of flat rate local exchange service and measured rate EAS.

<u>Criterion 4: Flat EAS rates should be asymmetrical between exchanges to reflect differences in the number of subscriber lines.</u>

The stipulated rates for each LEC comply with Criterion 4. Each of the LECs has developed a company-wide matrix of EAS rates, which satisfies Criterion 4. All companies, except Sprint, propose to maintain their current EAS matrix style. Sprint proposes to use the EAS matrix recently approved by the Commission. *See* Order No. 04-093. The remaining companies propose to charge for expanded EAS service based on their existing EAS matrix styles.

Criterion 5: One flat rate option should incorporate all EAS available to the customer.

The stipulated rates for each LEC comply with Criterion 5. All of these companies provide a flat rate option that incorporates all EAS routes available to customers in each exchange.

<u>Criterion 6: Flat EAS rates must include a residential/business differential under which business customers pay a higher flat rate.</u>

The stipulated rates for each LEC comply with Criterion 6. All of these companies charge a higher flat EAS rate to their business customers than to their residential customers.

Criterion 7: Measured EAS rates must be the same for business and residential customers.

The stipulated rates for each LEC comply with Criterion 7. All of these companies charge the same measured EAS rate to both residential and business customers.

<u>Criterion 8: EAS rates must recover the costs of switching and transport and make a contribution to common overhead and the cost of the local loop.</u>

The stipulated rates for each LEC substantially comply with Criterion 8. The proposed EAS revenues substantially recover traffic sensitive costs, such as the distributed costs of switching and transport, plus they provide a contribution to the cost of the local loop.

<u>Criterion 9: Revenue shortfalls due to new EAS routes must be made up first from company-wide EAS rates, then from company-wide local exchange rates.</u>

The stipulated rates for each LEC comply with Criterion 9. No Company will increase its local exchange rates in this proceeding.

Criterion 10: EAS tariff proposals should be revenue neutral.

The stipulated rates for each LEC substantially comply with Criterion 10. Under Criterion 10, the additional EAS revenues proposed should equal the sum of the cost shift attributed to the EAS conversion plus any additional costs for EAS. Deviations from revenue neutrality are either very small or the result of a LEC's decision to accept a net revenue loss.

Resolution

The Commission concludes that the Southern Oregon EAS Region should be implemented as proposed. The stipulated rates for each of the LECs satisfy the rate design criteria for EAS conversion and are just and reasonable. Accordingly, the Commission adopts the stipulated rates and other provisions included in the stipulations between Staff and the LECs, subject to the terms of this order.

ADDITIONAL ISSUES

Customer Notification

Customer notification is a critical part of any EAS implementation. Customers have the right to receive adequate information in an understandable format so that they can make informed decisions. The minimum requirements adopted by the Commission in Order No. 91-1140, accomplish that goal. The Commission will require the LECs to comply with those requirements, under which the companies shall, at a minimum, provide their customers the following:

1. Customers shall be permitted to change EAS options for a six-month period following implementation of EAS on October 2, 2004, without incurring a fee for the change in service.

2. A brochure with complete information about the company's EAS options and the rates for each shall be mailed to each customer prior to the date of implementation of service and once more 90 days after the EAS conversion.

3. The brochure should include:

- a. A simple, non technical explanation of how to calculate which option is to the customer's advantage, including a statement of the "break-even" point, *i.e.*, the number of minutes of EAS calling under measured service that would exceed the company's flat rate.
- b. A description of at least two methods for choosing the best option: (1) changing service and comparing bills; and (2) keeping a log and estimating minutes of use. A sample log and worksheet should be included.
- c. The brochure shall notify the customer that service can be changed at no charge for six months from implementation.
- d. The phone number of the company office, which can provide customers with additional assistance or information.
- e. A map depicting existing EAS exchanges and new exchanges for which EAS will become available.
- f. An explanation of the "default services." Customers should be informed of the type and cost of the EAS they will receive if they take no action.

It is important to note that the foregoing notification requirements do not apply to exchanges where EAS rates change, but no new EAS is implemented. For such exchanges, the LECs should follow ordinary procedures for notifying customers of rate changes. The LECs are strongly encouraged, however, to provide basic EAS information in these exchanges as well.

Measured Rate Option

Many senior citizens and others on fixed incomes commented that they do not make many long distance calls and need to keep their costs down. They also were under the impression that flat rate EAS is mandatory and an inevitable rising cost. We are aware that a flat rate increase could be a hardship for some customers. For these reasons, we emphasize that more must be done to publicize the measured rate option, particularly in the Sprint exchanges facing EAS flat rate increases. The measured rate

was discussed in the one page flyer sent to all telephone customers in the Region and at the open house meetings. We encourage the LECs to provide more information to make customers aware of this option.

CONCLUSIONS

Based on the record developed in these dockets, the Commission concludes that the proposed Southern Oregon EAS Region identified in Appendix A is in the public interest. The public comment and testimony on the proposed region reflect a significant demand for EAS. Calling pattern data or demographic evidence establishes that there is a community of interest between the affected exchanges. The proposed EAS rates are reasonable and in compliance with the Commission's rate design criteria for EAS conversion. The Region shall be implemented as proposed.

ORDER

IT IS ORDERED that:

- 1. The Southern Oregon Extended Area Service Region shall be implemented, as indicated by the map at Appendix A.
- 2. The stipulations entered between Staff and the four local exchange telephone companies, set forth in Appendices B through E, are approved.
- 3. The local exchange companies shall, at a minimum, provide their customers with notification of new EAS as described above.

4. Customers who do not select a type of EAS they have at the ti	an EAS option shall be defaulted to time of conversion.

Additionally, Qwest's Siletz customers will receive a non-optional, flat rate (pursuant to FCC Order No. 97-244) for the interLATA route to Lincoln City. The monthly non-optional, flat rate will be \$0.45 for residence customers and \$0.90 for business customers.

Qwest's 20 exchanges showing an increase in rates on the above list, but not marked with an "*", will experience the increase shown although these exchanges will receive no new EAS routes in this proceeding. This is considered normal since consistent with Criterion 4; EAS rates are applied statewide within each rate band.

Owest Measured EAS Rates

Customers in all exchanges are allowed a measured rate option for their intraLATA EAS, pursuant to Criterion 2. Customers can change EAS rate options at no charge for 90 days after the effective date of any change in EAS rates.

Qwest's measured EAS rate is \$0.04 per minute of use for weekday calls and \$0.02 per minute of use for night, weekend, and holiday calls. Qwest is not proposing an increase in its measured EAS rate in this proceeding.

Qwest Local Exchange Rates

Qwest monthly local exchange rates for residence service are \$12.80, \$13.80, and \$14.80 for rate groups 1, 2, and 3, respectively. Its monthly local exchange rates for business service are \$26.00, \$28.50, and \$30.50 for rate groups 1, 2, and 3, respectively. Qwest is not proposing an increase in its local exchange rate in this proceeding.

If the Commission approves the EAS petitions in this proceeding, and the related EAS matrix and rates proposed by Verizon, Customers of 17 Verizon exchanges will receive new EAS routes and customers of 12 Verizon exchanges will experience an increase in their EAS flat rate. Customers of the 14 Verizon exchanges in the Portland Region (EAS Bands V and Va) will not experience an increase although they will receive EAS to Government Camp. Verizon will recover its revenue loss and implementation costs associated with the new EAS routes through an increase in the rates for EAS Bands III and IV. Customers of the Bandon and Coquille exchanges will receive new EAS routes between the two exchanges and will experience an increase in their EAS flat rate because they are classified in EAS rate Band III A. Customers of nine Verizon exchanges classified as EAS rate Band III or IV (marked with an "*" on the list below) will experience an increase in their EAS flat rate although they receive no new EAS routes in this proceeding. Verizon's Measured EAS Rates

Customers in all exchanges are allowed an EAS measured rate option pursuant to Criterion 2. Customers can change EAS rate options at no charge for 90 days after the effective date of any change in EAS rates.

Verizon's measured EAS rate is \$0.04 per minute of use for weekday calls. A 50% discount applies to calls placed between 9 p.m. and 7:59 a.m. weekdays, and all day Saturday, Sunday, and holidays.

Verizon is not proposing an increase in its measured EAS rate in this proceeding.
