DISPOSITION: CERTIFICATE OF AUTHORITY CANCELLED

On September 26, 2001, Snip Link LLC was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 01-829.

Snip Link LLC has failed to file the Oregon Universal Service Fund Form 2 for the first quarter of 2004 as required per ORS 759.425.

The certificate holder failed to file an annual report for 2003 as required by OAR 860-032-0060(2)(a). On April 15, and May 17, 2004, the Commission notified the certificate holder that the report had not been received. The certificate holder failed to respond to the original request for the annual report and to the second notification.

No gross revenue late statement penalty fee was paid for 2003 as required by ORS 756.310. On April 19, May 14, and June 15, 2004, the Commission notified the certificate holder that the required fees were not received.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its July 20, 2004, Public Meeting that the certificate holder has failed to comply with Commission rules and terms of the certificate and the certificate of authority to provide telecommunications service should be cancelled, per OAR 860-032-0008 (2).

The Commission notes that this is the second time it has canceled the certificate held by the certificate holder. Before the Commission will process any future

application for recertification, the certificate holder must fully comply with the Commission's rules and regulations. Any future application must include:

- (1) Payment of all revenue fees, including late payment fees, owed for each calendar year of operation pursuant to ORS 756.310(6)(a) and in accordance with Commission requirements;
- (2) Confirmation of compliance with Oregon Universal Service Fund requirements pursuant to ORS 759.425; and
- (3) Annual reports for each calendar year of operation pursuant to OAR 860-032-0060.

The certificate holder must include all fees and documents for each year of operation, regardless of whether it held a valid certificate of authority from this Commission. In addition, the certificate holder must provide information to the Commission why it believes it is in the public interest to again grant a certificate of authority to an entity that has repeatedly ignored Commission rules. The Commission will evaluate the information to help determine whether to grant the application. If the certificate holder fails to include these items in its application, the Commission will deem the application incomplete and return it.
