DISPOSITION: CERTIFICATE OF AUTHORITY CANCELLED

On March 18, 2003, Miko Telephone Communications Inc. was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 03-163.

Miko Telephone Communications Inc. has failed to file the Oregon Universal Service Fund Form 2 for the first quarter of 2004 as required per ORS 759.425.

The certificate holder failed to file an annual report for 2003 as required by OAR 860-032-0060(2)(a). On April 15, and May 17, 2004, the Commission notified the certificate holder that the report had not been received. The certificate holder failed to respond to the original request for the annual report and to the second notification.

No revenue fees were paid for 2003 as required by ORS 756.310. On April 19, May 14, and June 15, 2004, the Commission notified the certificate holder that the required fees, statement, and accrued penalties were not received.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its July 20, 2004, Public Meeting that the certificate holder has failed to comply with Commission rules and terms of the certificate and the certificate of authority to provide telecommunications service should be cancelled, per OAR 860-032-0008 (2).

The Commission also concludes that it will not process a future application filed by the certificate holder for recertification as a competitive provider,

unless the certificate holder fully complies with the Commission's rules and regulations. Any future application must include:

- (1) Payment of all revenue fees, including late payment fees, owed for each calendar year of operation pursuant to ORS 756.310(6)(a) and in accordance with Commission requirements;
- (2) Confirmation of compliance with Oregon Universal Service Fund requirements pursuant to ORS 759.425; and
- (3) Annual reports for each calendar year of operation pursuant to OAR 860-032-0060.

The certificate holder must include all fees and documents for each year of operation, regardless of whether it held a valid certificate of authority from this Commission. If the certificate holder fails to include these items in its application, the Commission will deem the application incomplete and return it.

IT IS ORDERED that the certificate Communications Inc. is cancelled.	of authority held by Miko Telephone
