**DISPOSITION: PACIFICORP'S MOTION TO BIFURCATE ISSUES GRANTED; MOTION FOR EXTENSION OF STATUTORY DEADLINE GRANTED; MOTION TO WITHDRAW GRANTED**

On June 29, 2003, PacifiCorp filed an affiliated interest application pursuant to ORS 757.490, ORS 757.495, and OAR 860-027-0040. On November 3, 2004, PacifiCorp filed a motion to bifurcate issues and consented to an extension of the statutory deadline until March 31, 2005. PacifiCorp filed a separate motion on November 3, 2004 to withdraw a portion of its application.

**DISCUSSION**

The affiliated interest application filed by PacifiCorp sought authorization to secure property damage, liability, and workers compensation insurance from Dornoch Risk International Limited (Dornoch), a wholly owned subsidiary of ScottishPower plc (ScottishPower). PacifiCorp is also a subsidiary of ScottishPower, and therefore the business transactions to be conducted between PacifiCorp and Dornoch establish an affiliated interest.

In its motion, PacifiCorp sought to bifurcate the issue of providing liability insurance. PacifiCorp requests a bifurcation of the issue of liability insurance in order to obtain more definitive information on liability insurance premium costs, a concern expressed by Staff. Staff agreed to the motion on the condition that PacifiCorp consent to an extension of the statutory deadline for processing affiliated interest applications until March 31, 2005. PacifiCorp consents to the extension of time. PacifiCorp's request to bifurcate the issue and to secure property damage insurance was approved with conditions at the November 23, 2004 public meeting.

In the second motion filed separately, PacifiCorp sought to withdraw the portion of the application related to workers compensation. After discussions with Staff, PacifiCorp determined that it would withdraw its request to secure workers compensation insurance coverage from Dornoch at this time.

**CONCLUSION**

The motion to bifurcate the affiliated interest application of PacifiCorp is granted and through the consent of PacifiCorp, an extension of the statutory deadline is granted. The motion to withdraw a portion of PacifiCorp's application is also granted.

**ORDER**

IT IS ORDERED that

1. The motion to bifurcate the affiliated interest application of PacifiCorp is granted and an extension of the statutory deadline for processing the affiliated interest application is granted until March 31, 2005.
2. The motion to withdraw a portion of the application seeking authorization to secure workers compensation insurance is granted.
