# DISPOSITION: STIPULATION ADOPTED

On April 6, 2005, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with two violations of law and requested a penalty of \$1,000. On May 4, 2005, a copy of the complaint was served.

On May 27, 2005, the parties to this proceeding entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, Defendant admits committing the alleged violations and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant also agrees to complete, within 45 days following execution of the stipulation, a training session with the Oregon Utility Notification Center Speakers Bureau on Oregon excavation laws. A review of the Commission's records indicates that Defendant has completed the training session.

The parties further agree that a portion of the penalties should be suspended, unless Defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for a period of one year following the date of the Commission's final order in this proceeding. The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule(s) as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

## ORDER

## IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Defendant in the amount of \$1,000 for one violation of law.
- 3. Defendant shall pay the sum of \$200. The Commission acknowledges receipt of \$200 from Defendant.
- 4. Payment of the balance of the penalties (\$800) shall be suspended, unless a showing is made that Defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.
