DISPOSITION: JURISDICTION ASSERTED

On December 27, 2004, ROUND LAKE UTILITIES, INC. (Round Lake Utilities) sent a notice to its customers that it was raising its annual average monthly residential rate above the Public Utility Commission's (Commission) established threshold of \$24 (OAR 860-036-0030). On January 10, 2005, the Commission received petitions from 20 percent or more of Round Lake Utilities' customers requesting rate regulation. On January 28, 2005, the Commission Staff sent a letter notifying Round Lake Utilities that pursuant to OAR 860-036-0405 and ORS 757.061 jurisdiction would be asserted unless Round Lake Utilities requests a hearing by March 1, 2005, to explain why Round Lake Utilities is not subject to jurisdiction. A copy of Staff's letter is attached as Appendix A and incorporated by reference. Round Lake Utilities did not request a hearing, and the time for doing so has expired.

#### FINDINGS OF FACT

Round Lake Utilities provides water service to the public. Round Lake Utilities meets the definition of a public utility and is subject to rate regulation.

## **CONCLUSION OF LAW**

Round Lake Utilities is a public utility under ORS 757.005. Round Lake Utilities is subject to service and rate regulation pursuant to ORS 757.061. Round Lake Utilities should be classified as a rate regulated public utility.

## **ORDER**

IT IS ORDERED that Round Lake Utilities is a public utility subject to Commission rate and service jurisdiction under ORS 757.005 and 757.061. Pursuant to OAR 860-036-0410(6), Round Lake Utilities shall file appropriate tariffs pursuant to ORS 757.205 within 60 days from the date of this order.

# NOTICE OF INTENT TO ASSERT JURISDICTION

The Public Utility Commission (Commission) is directed by the Legislature to regulate privately-owned water companies providing service directly or indirectly to or for the public. See Oregon Revised Statutes (ORS) 757.005 (attached). The Commission regulates service quality (water quality, water pressure, customer service, and plant maintenance) for certain private water companies designated as public utilities. Additionally, the Commission regulates rates of water companies that either: (1) serve over 500 customers; or (2) charge more than an average annual monthly charge of \$24 for water service and whose customers have petitioned for Commission review. See ORS 757.061.

Our records show that on January 10, 2005, the Commission received petitions from 45 customers of Round Lake Sewer Company (Round Lake) which represents more than 20 percent of the customers. Therefore, pursuant to ORS 757.061(6)(b), Round Lake is subject to rate regulation.

The Commission established an average annual monthly residential rate threshold of \$24 (OAR 860-036-0030) as a trigger for potential rate regulation. In order to determine if rate regulation authority is asserted, Round Lake was required to provide 60 days written notice to its customers before raising its annual average monthly residential rate above the \$24 threshold (pursuant to OAR 860-036-0405 and ORS 757.061(6)(b)). That notice was sent to customer on December 27, 2004. The Commission intends to designate Round Lake as a public utility subject to rate service regulation and an annual gross revenue fee of .0025 percent of annual revenues.

## **HEARING RIGHTS**

Round Lake has the right to a hearing to dispute the Commission's assertion of jurisdiction. The Company may formally request a hearing. The notice must be filed within 30 days from the date of this letter. The request for hearing must include information that demonstrates that Round Lake is not subject to Commission jurisdiction. A request for hearing should be mailed to:
