### DISPOSITION: JURISDICTION ASSERTED

METOLIUS MEADOWS PROPERTY OWNERS ASSOCIATION (Metolius Meadows or Company) is an association providing water service to its membership and to customers who are not members of the association. On January 28, 2005, the Staff of the Public Utility Commission sent a letter to Metolius Meadows notifying the Company that it appeared to meet the definition of a public utility pursuant to ORS 757.005. The letter stated that Commission jurisdiction would be asserted unless Metolius Meadows requested a hearing by February 28, 2005, to explain why the Company was not subject to jurisdiction. A copy of Staff's letter is attached as Appendix A and incorporated by reference. Metolius Meadows did not request a hearing, and the time for doing so has expired.

## FINDINGS OF FACT


By providing water service to customers who are not members of the association, Metolius Meadows provides water service "to and for the public" (ORS 757.005).

#### **CONCLUSION OF LAW**

Metolius Meadows Property Owners Association is a public utility under ORS 757.005. Metolius Meadows Property Owners Association is subject to service regulation pursuant to ORS 757.061. Metolius Meadows Property Owners Association should be classified as a public utility.

#### ORDER

IT IS ORDERED that Metolius Meadows Property Owners Association is a public utility subject to Commission jurisdiction pursuant to ORS 757.005 and 757.061.



A party may request rehearing or reconsideration of this order pursuant to ORS 756.561. A request for rehearing or reconsideration must be filed with the commission within 60 days of the date of service of this order. The request must comply with the requirements in OAR 860-014-0095. A copy of any such request must also be served on each party to the proceeding as provided by OAR 860-013-0070(2). A party may appeal this order to a court pursuant to applicable law.

# NOTICE OF INTENT TO ASSERT JURISDICTION

The Public Utility Commission (Commission) is directed by the Legislature to regulate privatelyowned water companies providing service directly or indirectly to or for the public. *See* ORS 757.005 (attached). The Commission regulates service quality (water quality, water pressure, customer service, and plant maintenance) for certain private water companies designated as public utilities. Additionally, the Commission regulates rates of water companies that either: (1) serve over 500 customers; or (2) charge more than an average annual monthly charge of \$24 for water service and whose customers have petitioned for Commission review. *See* ORS 757.061.

Our records show that Metolius Meadows Property Owners Association (Metolius Meadows) serves 11 members outside its membership. When an association serves customers outside of its membership, it becomes subject to Commission jurisdiction. Metolius Meadows is considered to be serving water to and for the public and therefore, meets the definition of a public utility, pursuant to ORS 757.005. The Commission intends to designate Metolius Meadows as a public utility subject to service regulation and an annual gross revenue fee of .0025 percent of annual revenues.

#### **HEARING RIGHTS**

Metolius Meadows has the right to a hearing to dispute the Commission's assertion of jurisdiction. The Company may formally request a hearing. The notice must be filed within 30 days from the date of this letter. The request for hearing must include information that demonstrates that Metolius Meadows is not subject to Commission jurisdiction. A request for hearing should be mailed to:

If no request for hearing is filed within 30 days, the Commission will designate the information in its files as the record in this matter and issue an order asserting jurisdiction.
