## **INTRODUCTION**

On April 14, 2005, Andrew Thayer submitted a letter to the Public Utility Commission of Oregon (PUC) advising that on March 28, 2005, customers of Laurelwood Water Systems, Inc., formed an association. Along with the letter, Mr. Thayer submitted a copy of the Articles of Incorporation (attached as Appendix A) filed with the Secretary of State on behalf of LAURELWOOD WATER ASSOCIATION, INC.

### **FINDINGS OF FACT**

LAURELWOOD WATER ASSOCIATION, INC., is an association that provides water service only to members of the association.

Twenty percent or more of the members of LAURELWOOD WATER ASSOCIATION, INC., have not filed petitions with the PUC requesting that the association be subject to regulation by the PUC.

## **CONCLUSIONS OF LAW**

LAURELWOOD WATER ASSOCIATION, INC., is no longer a public utility as defined in ORS 757.005 because it does not provide water service directly or indirectly to or for the public as defined in ORS 757.005(1)(a)(A), and 20 percent or more of the members have not filed petitions with the PUC pursuant to ORS 757.063.

## ORDER

IT IS ORDERED that LAURELWOOD WATER ASSOCIATION, INC., is no longer a public utility as defined under ORS 757.005 or ORS 757.063.

#### EXHIBIT "A"

- 8) There will be no new membership fee charged to property owners who are currently receiving water from Laurelwood Water system, Inc. Property owners who apply for new membership or additional memberships will be assessed a membership fee of \$500.00. Memberships can only be transferred to property owners who are served by the water system, subject to approval of the Board of Directors.
- 9) this corporation may be dissolved by resolution passed by a majority vote of the Board of Directors. The members at any duly called meeting of the members may adopt a motion directing the Board of Directors to initiate voluntary dissolution or liquidation of the cooperative. In either case, the notice of such a meeting must state that the dissolution or liquidation is up for consideration. If a motion or resolution to dissolve or liquidate is adopted, the motion or resolution shall include the manner of distribution of assets, and this manner may provide that the balance of the assets, after the payments of all debts of the cooperative have been paid in full, shall be reduced to cash and equally divided among the members, provided that any sum due the cooperative by a member shall be deducted from the member's share and the total deductions shall then be divided among the members. In the event that at the time the meeting is called to propose the dissolution or liquidation of the cooperative, if all or part of the assets of the cooperative are mortgaged or otherwise hypothecated. notice of the proposed meeting and its purpose must be delivered to the agent to whom payments on the mortgage indebtedness are or should be paid, and, thereafter, the mortgage holder shall have the option at any time within ninety (90) days of receipt of notice to elect to purchase the assets of the cooperative at their value subject to the mortgage or to arrange for a sale and transfer to some other person, group or entity at their value subject to the mortgage.

In the alternative, the assets may be distributed to a legal entity that agrees to continue operating and maintaining the water system.
