ORDER

**DISPOSITION: CANCELLATION OF CERTIFICATE OF SERVICE  
RESCINDED**

On July 30, 2004, the Commission granted a certificate of authority to Inmate Calling Solutions LLC (ICS) to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 04-411.

At its April 19, 2005, public meeting, the Commission determined that ICS's certificate of authority should be cancelled, and orally cancelled ICS's certificate of authority, based on the Staff Report dated April 12, 2005. However, immediately following the April 19, 2005, public meeting, Staff informed the Commission that it had inadvertently listed an incorrect docket number in its prior staff report, and ICS's certificate of authority should not have been cancelled.

In its May 6, 2005, Staff Report, attached as Appendix A, Staff stated that it had inadvertently listed an incorrect docket number in its prior staff report, and recommended that the Commission rescind the cancellation of ICS's certificate of authority.


Under the circumstances, the cancellation of ICS's certificate should be rescinded.

**STAFF RECOMMENDATION:**

Staff recommends rescinding the cancellation of the certificate of authority in Docket No. CP 1241, Inmate Calling Solutions LLC, and canceling the certificate of authority in Docket No. CP 1085, Inmate Communications Corp.

**DISCUSSION:**

At the April 19, 2005, Public Meeting, staff listed an incorrect docket number in its public meeting memo and the certificate of authority in Docket No. CP 1241, Inmate Calling Solutions, LLC, was inadvertently canceled. The certificate of authority in Docket No. CP 1085, Inmate Communications Corp., scheduled to be canceled for the provider's failure to file its 2004 4<sup>th</sup> Quarter OUS2 report, was not canceled.

**PROPOSED COMMISSION MOTION:**

The cancellation of the certificate of authority in Docket No. CP 1241, Inmate Calling Solutions LLC, is rescinded. The certificate of authority in Docket No. CP 1085, Inmate Communications Corp., is canceled.
