ORDER

**DISPOSITION: MONETARY PENALTIES ASSESSED**

On April 4, 2005, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of OAR 952-001-0050, by failing to notify the Oregon Utility Notification Center of a proposed excavation prior to excavating.

Duplicate originals of the complaint were served on Defendant on April 11, 2005, as follows: (1) Ed Thompson, Registered Agent, Brant Construction Inc., 111 SW Columbia, Portland, Oregon 97201-5897, and (2) Mike Shaw, Brant Construction, Inc., 2005 Broadway, Vancouver, Washington 98663-3366. Defendant was notified in the complaint, that failure to answer or otherwise appear within 20 days after service would be deemed a default. Furthermore, all material allegations of the complaint would be deemed admitted, hearing waived, penalties imposed, and the matter disposed of by appropriate order without further notice.

On April 18, 2005, the envelope addressed to Ed Thompson, Registered Agent, at the aforementioned address was returned from the Post Office, stamped "Not At This Address, Insufficient Address, Return to Sender." However, the envelope addressed to Mike Shaw at aforementioned address was not returned.

Defendant failed to file an answer or otherwise plead or appear within the time specified.


From the foregoing, it is concluded that Defendant is in default, all material allegations of the complaint are deemed admitted, hearing waived, and that, pursuant to ORS 757.993, civil monetary penalties should be assessed against Defendant in the amount of \$1,000.


**ORDER**

IT IS ORDERED that:

1. Civil monetary penalties in the amount of \$1,000 are assessed against BRANT CONSTRUCTION, INC. (a Washington corporation).
2. Defendant shall pay the sum of \$1,000, due and payable within 30 days from the date of service of this order. (Mail payment to: Public Utility Commission of Oregon, PO Box 2153, Salem, OR 97308.)
