DISPOSITION: CERTIFICATE OF AUTHORITY CANCELLED

On June 7, 2004, Comm360 Software Inc. was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 04-311.

The certificate holder failed to file an annual report for 2004 as required by OAR 860-032-0060(2)(a). The Commission notified the certificate holder by telephone or electronic mail that the report had not been received. The certificate holder failed to respond to the original request for the annual report and to the second notification.

No revenue fees were paid for 2004 as required by ORS 756.310. On April 28, and May 27, 2005, the Commission notified the certificate holder that the required fees were not received. On July 8, 2005, a Fee Assessment Order in docket No. FA 477, Order No. 05-830, was sent to the company.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its August 2, 2005, Public Meeting that the certificate holder has failed to comply with Commission rules and terms of the certificate. The certificate of authority to provide telecommunications service should be cancelled, per OAR 860-032-0008(2).

The Commission also concludes that it will not process a future application filed by the certificate holder for certification as a competitive provider, unless the certificate holder fully complies with Commission rules. Any future application must include:

1. Payment of all revenue fees, including late payment fees, owed for each calendar year of operation pursuant to ORS 756.310(6)(a), in accordance with Commission requirements;
2. Confirmation of compliance with Oregon Universal Service Fund requirements pursuant to ORS 759.425; and

- 3. Annual reports for each calendar year of operation pursuant to OAR 860-032-0060.

The certificate holder must include all fees and documents for each year of operation, regardless of whether it held a valid certificate of authority from this Commission. If the certificate holder fails to include these items with its application, the Commission will deem the application incomplete and return it.

IT IS ORDERED that the certificate of authority held by Comm360 Software Inc. is cancelled.
