**DISPOSITION: PAYMENT OF FUNDS ORDERED**

On January 4, 2006, the Citizens' Utility Board of Oregon (CUB) filed a request with the Public Utility Commission of Oregon (Commission) for payment of CUB Fund Grants for the year 2006. The request is pursuant to the terms of the Intervenor Funding Agreement (Agreement), approved by the Commission in Order No. 03-388.


Section 7.1 of the Agreement provides that "[u]pon request by CUB, the Commission will direct the Participating Public Utilities to pay the amounts made available for CUB Fund Grants pursuant to the terms of this agreement." The amounts made available for the CUB Fund Grants are \$50,000 for each of the three participating public utilities, which are PacifiCorp, Portland General Electric and Northwest Natural Gas Company. The Agreement states that the utilities shall pay the amounts no later than 30 days after receipt of this order.


**ORDER**
