DISPOSITION: MONETARY PENALTIES ASSESSED

On December 13, 2005, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of law, OAR 952-001-0050, by failing to notify the Oregon Utility Notification Center of a proposed excavation prior to excavating.

Triplicate originals of the complaint were served on Defendant on December 16, 2005, as follows: (1) David Hall, New Tech Electric, Inc. 13970 SW 72nd Avenue, Portland, OR 97224, (2) Charles Crouser, Authorized Representative, New Tech Electrical, Inc., 6950 NE Campus Way, Hillsboro, OR 97124, and (3) William A. Coleman, Registered Agent, New Technology Electrical Contractors, Inc., dba New Tech Electric, Inc., 1400 NE 48th Avenue, Hillsboro, OR 97124. Defendant was notified in the complaint, that failure to answer or otherwise appear within 20 days after service would be deemed a default. Furthermore, all material allegations of the complaint would be deemed admitted, hearing waived, penalties imposed, and the matter disposed of by appropriate order without further notice.

On January 9, 2006, the envelopes addressed to Charles Crouser and William A. Coleman were returned from the Post Office, stamped "Undeliverable As Addressed, Unable to Forward, Returned to Sender." However, the envelope addressed to David Hall was not returned.

Defendant failed to file an answer or otherwise plead or appear within the time specified.

From the foregoing, it is concluded that Defendant is in default, all material allegations of the complaint are deemed admitted, hearing waived, and that, pursuant to ORS 757.993, civil monetary penalties should be assessed against Defendant in the amount of \$1,000.

ORDER

IT IS ORDERED that:

Made, entered, and effective

- 1. Civil monetary penalties in the amount of \$1,000 are assessed against Defendant.
- 2. Defendant shall pay the sum of \$1,000, due and payable within 30 days from the date of service of this order. Payment shall be by <u>cashier's check or money order</u> made out to the **Public Utility Commission of Oregon**, and the <u>memo line of the cashier's check or money order shall state the "NC" docket number</u> in the caption of this order.
