DISPOSITION: AMENDMENT APPROVED

On October 19, 2006, Integra Telecom of Oregon, Inc. and Qwest Corporation (Qwest) filed a twenty-fourth amendment to the interconnection agreement previously acknowledged by the Public Utility Commission of Oregon (Commission), recognizing the adoption of ARB 3 terms. Subsequent amendments were approved with Orders No. 00-575, 00-629, 01-793, 01-917, 02-081, 02-241, 02-597, 03-113, 03-555, 04-118, 04-175, 05-098, 05-215, 05-915, 05-1018, 06-208, 06-436, and 06-650. ARB 219(22) was withdrawn by Qwest on October 13, 2006. The parties seek approval of the amendment under Section 252(e) of the Telecommunications Act of 1996. The amendment adopts a wholesale collocation promotion offered by Qwest. The Commission provided notice by posting an electronic copy of the agreement and amendment on the World Wide Web, at: <http://www.puc.state.or.us/caragmnt/>.

Qwest previously sought approval of the wholesale promotion, under OAR 860-016-0021, in docket ARB 771. On October 23, 2006, the Commission approved Qwest's promotion in Order No. 06-592.

When a carrier accepts a promotional offering, the accepting carrier and the offering carrier must file any required amendment to their existing carrier-to-carrier agreement. To qualify for expedited review under OAR 860-016-0021, the amendment must be identical to the promotion previously acknowledged by the Commission.

The Commission has reviewed the amendment under the standards set forth in OAR 860-016-0020 and Section 252(e) of the Telecommunications Act of 1996 and concludes that it should be approved.

OPINION

The Commission concludes that the amendment to the agreement adopting the promotion does not appear to discriminate against telecommunications carriers who are not parties to the agreement and does not appear to be inconsistent with the public interest, convenience, and necessity. Accordingly, the amendment should be approved.

CONCLUSIONS

1. There is no basis for finding that the amendment to the previously approved agreement discriminates against any telecommunications carrier who is not a party to the agreement.
2. There is no basis for finding that implementation of the amended agreement is not consistent with the public interest, convenience, and necessity.
3. The amendment should be approved.

ORDER

IT IS ORDERED that the amendment to the previously approved agreement between Integra Telecom of Oregon, Inc. and Qwest Corporation is approved.
