

DISPOSITION: TARIFF SHEETS SUSPENDED

On October 20, 2006, IDAHO POWER COMPANY filed tariff sheets in Advice No. 06-10 to be effective November 20, 2006. The terms of the proposed tariff sheets are set forth in the Staff Report dated October 30, 2006, attached as the Appendix to this order.

At its November 7, 2006, public meeting, the Public Utility Commission of Oregon found good and sufficient cause exists to investigate the propriety and reasonableness of the tariff sheets pursuant to ORS 757.210 and 757.215. The Commission ordered suspension of the advice pending that investigation. IT IS ORDERED that Advice No. 06-10 filed by IDAHO POWER COMPANY is suspended for a period of time not to exceed six months from November 20, 2006, the effective date of the tariff sheets.



A party may request rehearing or reconsideration of this order pursuant to ORS 756.561. A request for rehearing or reconsideration must be filed with the Commission within 60 days of the date of service of this order. The request must comply with the requirements in OAR 860-014-0095. A copy of any such request must also be served on each party to the proceeding as provided by OAR 860-013-0070(2). A party may appeal this order by filing a petition for review with the Court of Appeals in compliance with ORS 183.480-183.484.

STAFF RECOMMENDATION:

Staff recommends the Commission suspend Pacific Power & Light's Advice No. 06-019, Portland General Electric's Advice No. 06-26, and Idaho Power Company's Advice No. 06-10 to allow staff time to review whether the filings comply fully with Order No. 06-538.

DISCUSSION:

Pacific Power, Portland General Electric (PGE) and Idaho Power made filings on October 20, 2006, in compliance with Order No. 06-538 (Order), issued September 20, 2006. The Order required the utilities to file, within 30 days, one or more revised standard contract forms that set forth standard rates, terms and conditions for Qualifying Facilities (QFs) consistent with policy decisions made in the Order. The Order further

required each utility to file a revised tariff that implements the resolutions in the Order. The revised standard contract forms and tariffs were to become effective 30 days after the date of filing unless suspended by the Commission. See Order No. 06-538 at 67-68.

Pacific Power filed three standard contract forms for QFs up to 10 megawatts, one each for existing and new QFs in its service territory and one for QFs outside its service territory ("off-system" QFs). PGE filed two standard contract forms – one for QFs within its territory and one for off-system QFs.

Idaho Power filed one standard contract form, for QFs in its service territory. At staff's request, the company has agreed to file a standard contract form for off-system QFs that includes the off-system provisions approved at the public meeting on December 6, 2005, and also complies with provisions of Order No. 06-538.

Staff needs time to appropriately review the filings to ensure they comply fully with the Order. Staff intends to complete its review by the end of the year. Until that time, the filed standard contract forms are considered "initial offers." *See* Order No. 06-538 at 67. It is staff's understanding that until such time as the newly filed standard contract forms go into effect, the utility will offer them to QFs, and QFs can accept any filed contract as is, or negotiate different terms with the utility.

PROPOSED COMMISSION MOTION:

Pacific Power & Light's Advice No. 06-019, Portland General Electric's Advice No. 06-26, and Idaho Power Company's Advice No. 06-10, be suspended, to allow staff time to review whether the filings comply fully with Order No. 06-538.
