DISPOSITION: STIPULATION ADOPTED

On November 6, 2006, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with one violation of law, OAR 952-001-0070. Defendant committed the violation described in this complaint within one year from the date a prior order was issued. *See* Order No. 06-113. A penalty shall be imposed in the amount of \$5,000 for the violation alleged, and the \$800 penalty that was suspended in Order No. 06-113 entered against Defendant shall be reinstated, for a total penalty of \$5,800. On November 11, 2006, a copy of the complaint was served.

On November 22, 2006, the parties to this proceeding entered into a stipulation, which is attached as Appendix A.

Defendant admits committing the violation alleged in the complaint. The stipulation is adopted.

From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. Civil monetary penalties shall be assessed against Verizon Northwest Inc. in the amount of \$5,000 for one violation of law.
- 2. Payment of the balance of the penalties (\$800) from Order No. 06-113 entered against Defendant shall be reinstated.
- 3. Defendant shall pay the sum of \$3,300, due and payable within 30 days from the date of service of this order. Payment shall be by check made out to the **Public Utility Commission of Oregon**, and the <a href="memoline of the check shall state the "NC" docket number in the caption of this order. (Mail payment to: Public Utility Commission of Oregon, PO Box 2153, Salem, OR 97308.)
- 4. Payment of the unpaid balance of the amount assessed (\$2,500) shall be suspended, unless Defendant fails to comply with paragraph 3 above or a showing is made that Defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center.
- 5. If Defendant has not paid the amount assessed in paragraph 3 above within 30 days from the date of service of this order, then Defendant shall pay the amounts assessed in paragraphs 1 and 2 above. Such payment shall be due immediately following the expiration of the time period set out in paragraph 3 above.
