DISPOSITION: APPLICATION APPROVED


On November 2, 2006, Central Lincoln People’s Utility District (CLPUD) filed an application requesting that two parcel areas be allocated to it as exclusively served territory. CLPUD already serves several customers and one of its own microwave hilltop tower sites in the territory proposed for allocation. A general description of the property is attached as Appendix A and is incorporated by reference.

Commission Staff finds that the parcels are located in unallocated territory and that CLPUD is currently servicing customers in both areas. Staff concludes that granting the application will therefore best facilitate the provision of economical, safe, efficient, and reliable service in the territory. The approval of the application will enable CLPUD to provide exclusive electric utility service within the area and will thus prevent the duplication of facilities. The territory allocation modifications are acceptable and not contrary to the public interest.


ORDER
