## DISPOSITION: ORDER NO. 07-150 AMENDED TO CORRECT DOCKET NUMBER OF ARB 213(1) AND IS TRANSFERRED TO DOCKET ARB 400

On April 10, 2007, the Public Utility Commission of Oregon (Commission) approved negotiated agreements and amendments in four separate dockets, pursuant to Section 252(e) of the Telecommunications Act of 1996. *See* Order No. 07-150.

One of the approved amendments was ARB 213, filed by PriorityOne Telecommunications, Inc. and Verizon Northwest Inc. (Verizon). On June 26, 2007, Verizon filed a Motion to Amend (Motion) Order No. 07-150. The Motion states that Verizon misfiled the First Amendment in docket ARB 213 rather than in docket ARB 400, and requests the Commission to amend Order No. 07-150 by replacing all references to ARB 213(1) with ARB 400(1). Further, Verizon requests the Commission to transfer the First Amendment and Staff Report, filed on March 1 and 26, 2007, respectively, in docket ARB 213, and Order No. 07-150, as amended, to docket ARB 400. No party filed an objection to the Motion.

Pursuant to Oregon Revised Statute 756.568, the Commission may amend its Orders. Granting this motion would not affect any party's substantive rights or responsibilities under the underlying agreements. It is a clerical correction to conform the Commission order to the actual decision intended and followed. Verizon's Motion is granted.

#### ORDER

#### IT IS ORDERED that:

- 1. Order No. 07-150 is hereby corrected by striking the language "ARB 213(1)" and substituting "ARB 400(1)" in its place.
- 2. The correction to Order No. 07-150 is hereby entered *nunc pro tunc* as of April 10, 2007, the date of the decision approving the amendment.
- 3. The First Amendment and Staff Report, filed on March 1 and 26, 2007, respectively, in docket ARB 213, and Order No. 07-150, as amended, are hereby transferred to docket ARB 400.
- 4. The remainder of Order No. 07-150 is unchanged.
