DISPOSITION: REALLOCATION APPROVED

The 2005 Legislature changed Oregon's territory allocation law for telecommunications utilities and telecommunications cooperatives. The new law allocates local exchange telecommunications service territory as a geographic area within boundaries set forth in exchange maps filed with and approved by the Commission. This replaces the old "metes and bounds" descriptions. ORS 759.500(1).

Section 27, chapter 232, Oregon Laws 2005, directs the Commission

to:

Reallocate every allocated local exchange telecommunications service territory to a telecommunications utility, cooperative corporation or municipality to whom the commission had previously allocated local exchange telecommunications service territory. Allocations granted by the commission pursuant to this subsection shall replace all allocations to telecommunications utilities, cooperative corporations or municipalities granted by the commission prior to January 1, 2006.

Staff recommends the reallocation of Clear Creek Mutual Telephone Company's (Clear Creek) local exchange telecommunications service territory using the boundaries of the exchange map filed with and approved by the Commission, as set forth in Table 1 of Appendix A, replacing all previous territory allocations for Clear Creek.

ORDER

IT IS ORDERED that Clear Creek Mutual Telephone Company's local exchange telecommunications service territory is reallocated using the boundaries of the exchange map filed with and approved by the Commission as set forth in Table 1 contained in Appendix A, replacing all previous territory allocations for Clear Creek Mutual Telephone Company.

STAFF RECOMMENDATION:

Reallocate Clear Creek Mutual Telephone Company's local exchange telecommunications service territory using the boundaries of the exchange map filed with and approved by the Commission as set forth in Table 1. This reallocation replaces all previous territory allocations for Clear Creek Mutual Telephone Company (Clear Creek).

DISCUSSION:

The 2005 Legislature changed Oregon's territory allocation law for telecommunications utilities and telecommunications cooperatives. The new law allocates local exchange telecommunications service territory (service territory) as a geographic area within boundaries set forth in exchange maps filed with and approved by the Commission. This replaces the old "metes and bounds" descriptions. See ORS 759.500(1).

Section 27, chapter 232, Oregon Laws 2005, subsection (1) directs the Commission to: "Reallocate every allocated local exchange telecommunications service territory to a telecommunications utility, cooperative corporation or municipality to whom the Commission had previously allocated local exchange telecommunications service territory. Allocations granted by the commission pursuant to this subsection shall replace all allocations to telecommunications utilities, cooperative corporations or municipalities granted by the commission prior to January 1, 2006."

The Commission previously allocated local exchange telecommunications service territory to Clear Creek in an order issued in 2002. Staff reviewed the Commission's records to identify all Clear Creek territory allocation orders issued prior to January 1, 2006, and currently in effect.

Clear Creek has a Commission-approved map on file for the company's local exchange, Redland. Staff concluded that Clear Creek's map is wholly or partially within the metes and bounds description in the company's previous territory allocation order.

On November 26, 2007, Staff sent Clear Creek a letter describing staff's conclusions in detail, and asking Clear Creek to make corrections, if any, by December 10, 2007. Clear Creek confirmed Staff's basic conclusion regarding the relationship between the previous territory allocation order and the approved local exchange map.

Table 1 describes reallocation for Clear Creek in detail. Reallocations are identified by exchange name and the effective date of the corresponding Commission-approved exchange map. Previous allocation is identified by Commission order number.
