### DISPOSITION: ISSUE FUND GRANT REQUEST APPROVED

On March 25, 2008, the Northwest Industrial Gas Users (NWIGU) filed a Request for Partial Payment of Northwest Natural Gas Company, dba NW Natural's (NW Natural) Issue Fund Grant with the Public Utility Commission of Oregon (Commission). Section 7.3 of the Intervenor Funding Agreement (Agreement), which the Commission adopted in Order No. 03-388, governs the procedures for payment of Issue Fund Grants.<sup>1</sup>

On January 23, 2007, NWIGU submitted a proposed budget of \$10,075, assuming a fully litigated case. The Commission approved NWIGU's proposed budget in Order No. 07-068. On December 28, 2007, NWIGU requested a partial payment in the amount of \$5,674.93 for costs incurred through October 31, 2007, and on January 16, 2008, in Order No. 08-014, the Commission approved that request.

NWIGU now seeks payment of costs incurred November 1, 2007, through December 31, 2007, amounting to \$292.50. NWIGU further requests that the remainder of its Issue Fund Grant budget amount continue to be reserved pending further requests for payment in this proceeding. Under Section 7.3 of the Agreement, the Request for Payment must:

- 1) Itemize the expenses, payees and hourly rates of amount to be reimbursed;
- Demonstrate that the expenses are reasonable and are directly attributable to issues and positions pursued on behalf of a particular customer class and consistent with the intervenor's proposed budget; and

3) Provide information sufficient to show that the intervenor has complied with any conditions imposed on the Issue Fund Grant.

The Agreement provides that the Commission shall make a determination in each proceeding as to how the participating utilities are to recover the funding grants from the various customer classes. Pursuant to Section 7.7(b), Issue Fund Grants should be allocated so as to fairly align the costs of the advocacy with the intended potential beneficiaries of the advocacy.

We find that NWIGU has met the requirements of the Agreement, and its request should be approved. We have considered the intended beneficiaries, and find that the issue fund expenditures should be allocated to NW Natural's industrial customers. Section 7.2 of the Agreement provides that the utility shall pay the Issue Fund Grant to the requesting intervenor within 30 days after receipt of Commission directive.

#### ORDER

IT IS ORDERED that:

- 1. Northwest Industrial Gas Users has met the requirements of the Intervenor Funding Agreement, and its request is approved.
- 2. Northwest Natural Gas Company, dba NW Natural shall pay \$292.50 from the NW Natural Issue Fund to the Northwest Industrial Gas Users within 30 days after receipt of this Order, and the grant shall be assessed to NW Natural's industrial customers.
