DISPOSITION: APPLICATION APPROVED

On March 13, 2008, Portland General Electric Company (PGE), filed an application, with the Public Utility Commission of Oregon (Commission), requesting the Commission waive the filing requirements under OAR 860-038-0200(5) that requires a report of unbundled costs to be filed with the annual results of operations report.

Division 038 of the Commission's rules was adopted in response to the passage of Senate Bill 1149 that, in part, directed the Commission to restructure the provision of electricity service to allow certain customers to purchase electricity in the wholesale market. The purpose of OAR 860-038-0200(5) was to enable regulatory oversight of the allocation of restructuring costs between classes of customers to avoid cross-subsidization.

To a large extent the ratemaking and regulatory expectations that existed when the Division 038 rules were adopted no longer exist. A full description of the filing and its procedural history and Staff's recommendation are contained in the Staff Report, attached as Appendix A and incorporated by reference.

At its Public Meeting on April 8, 2008, the Commission adopted Staff's recommendation, and approved PGE's application to waive the requirements of OAR 860-038-0200(5) that requires a report of unbundled costs to be filed with the annual results of operations report.

ORDER

IT IS ORDERED that Portland General Electric's application to waive the part of OAR 860-038-0200(5) that requires a report of unbundled costs to be filed with the annual results of operations report, is granted.

STAFF RECOMMENDATION:

I recommend that Portland General Electric's petition be approved to waive the part of OAR 860-038-0200(5)¹ that requires a report of unbundled costs to be filed with the annual results of operations report.

DISCUSSION:

Division 038 of the Commission's rules was adopted in response to the passage of Senate Bill 1149 that in part directed the Commission to restructure the provision of electricity service to allow certain customers to purchase electricity in the wholesale market. The purpose of OAR 860-038-0200(5) was to enable regulatory oversight of the allocation of restructuring costs between classes of customers to avoid cross-subsidization.

To a large extent the ratemaking and regulatory expectations that existed when the Division 038 rules were adopted no longer exist. It was anticipated that utility costs and revenues would be substantially unbundled and the annual review of unbundled costs

The electric company filing must clearly identify the allocation factor(s) used to functionalize each rate base, expense, and revenue item. and allocations would be necessary. The OAR itself contemplates "allocation and functionalization procedures adopted by the Commission." That, however, has not yet happened. At this point, the unbundled costs and identified cost allocation factors used to functionalize the rate base, expense, and revenue items are only used by PGE to establish rates as part of a rate case filing and may be used by other parties during that proceeding. By this application, PGE does not propose to change its accounting procedures, so nothing would prevent the generation of unbundled results of operations reports (unbundled reports) as necessary for a rate case or in response to a Commission request.

This filing only requests to discontinue filing unbundled reports on an annual basis. The other rule requirements would still apply. The steps to create an unbundled report require significant time and resources that are paid for by ratepayers. The elimination of unnecessary expense is an important consideration in this request. Although Staff does not generally recommend and the Commission does not favor exempting a utility from compliance with an administrative rule, the Commission has on occasion found it to be in the public interest to grant such a request.³ As the annual report is not used by Staff or the Company for any business purpose between rate cases, I am persuaded that PGE's application is in the public interest and recommend the Commission approve it.

Staff discussed this filing with both the Industrial Customers of Northwest Utilities and Citizens' Utility Board and neither organization opposes PGE's request.

PROPOSED COMMISSION MOTION:

PGE's application to waive the part of OAR 860-038-0200(5) that requires a report of unbundled costs to be filed with the annual results of operations report be granted.
