**DISPOSITION: CHARGES ASSESSED**

The Public Utility Commission of Oregon (Commission) has designated its files on the subject of this matter as the record in this case. Based on information contained in those files, the Commission makes the following:

**FINDINGS OF FACT**

LDC TELECOMMUNICATIONS INC. is a telecommunications provider required to submit quarterly contribution worksheets and payments to the Commission for the Oregon Universal Service Fund (OUSF). *See* ORS 759.425, and OAR 860-032-0620.

LDC TELECOMMUNICATIONS INC. failed to submit the quarterly contribution worksheet(s) and payment(s) by the due date(s) as set out in OAR 860-032-0620(3).

The Commission sent a Proposed Order to LDC TELECOMMUNICATIONS INC. on March 14, 2008. LDC TELECOMMUNICATIONS INC. did not respond.

Pursuant to OAR 860-032-0620 and OAR 860-032-0630, the Commission has proposed LDC TELECOMMUNICATIONS INC. owes the \$100 late statement fee for the third quarter of 2007.

Where applicable, the interest amount is calculated as of the date of this order. The interest will continue to accrue at 9 percent per annum until the Commission receives full contribution payment. *See* OAR 860-032-0620(7). **Conclusions**

LDC TELECOMMUNICATIONS INC. failed to provide quarterly contribution worksheet(s) and payments required by law. The amount set forth above should be assessed, with the exception that the interest, where applicable, will continue to accrue at 9 percent per annum until the Commission receives full contribution payment.

**ORDER**

IT IS ORDERED that the above amounts are assessed against LDC TELECOMMUNICATIONS INC. and are immediately due and payable to the Public Utility Commission, PO Box 2153, Salem, Oregon 97308-2153.
