**DISPOSITION: PROPOSED BUDGETS FOR ISSUE FUND
GRANTS APPROVED**

On May 28, 2008, the Industrial Customers of Northwest Utilities (ICNU) filed a proposed budget for an Issue Fund Grant in this proceeding. The Citizens' Utility Board of Oregon (CUB) filed its proposed budget for an Issue Fund Grant on May 29, 2008. ICNU seeks an Issue Fund Grant in the amount of \$33,680, and CUB seeks an Issue Fund Grant in the amount of \$8,640.

The First Amended and Restated Intervenor Funding Agreement (IFA), approved by the Commission in Order No. 07-564, provides that precertified intervenors must submit a proposed issue fund budget to the Commission that contains, at a minimum, the following information:

- 1) A statement of the work to be performed;
- 2) A description of the areas to be investigated;
- 3) A description of the particular customer class(es) that will benefit from the intervenor's participation;
- 4) Identification of the specific fund accounts from which the intervenor is seeking monies and an estimate of the amount of available funds in that account;
- 5) A budget showing estimated attorney, consultant and expert witness fees, which may include the cost for appropriate support staff and operations support; and

- 6) A representation that the intervenor will use matching funds in the form of either in-house resources or outside funding to account for or pay at least 20 percent of the eligible expenses for which the intervenor is seeking an Issue Fund Grant.

Once a proposed budget is received, we decide whether an Issue Fund Grant is available for use based on factors identified in the agreement. We have the authority to accept, deny or partially deny the request, and may place reasonable conditions on the grant.

ICNU became precertified on August 21, 2003, in Order No. 03-502. CUB was automatically precertified to receive Issue Fund Grants under Section 5.2(a) of the IFA and OAR 860-012-0100(3)(a). The proposed budgets of ICNU and CUB include the requisite information and reflect the current schedule adopted in this docket.

In light of the issues being addressed, the complexity of the issues and the significant policy decisions to be made, we believe that the proposed budgets of ICNU and CUB are reasonable and should be approved. However, the Commission's records show that granting all of the pending proposed budgets from the PGE Issue Fund, in this and other open dockets, will account for all but \$855 of the available PGE Issue Fund monies for 2008. Therefore, the Commission cautions the intervenors that approval of all of the pending PGE Issue Fund budget requests will essentially preclude the availability of such funds for any new qualifying proceedings for the remainder of the year.


ORDER

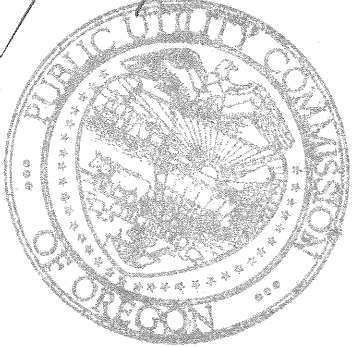
