On May 16, 2008, OLD SHEEP RANCH WATER ASSOCIATION filed tariff sheets in Advice No. 08-28 to be effective July 1, 2008. The terms of the proposed tariff sheets are set forth in the Staff Report dated June 2, 2008, attached as the Appendix to this order.

STAFF RECOMMENDATION:

Pursuant to ORS 757.215, Staff recommends that proposed tariffs filed with Old Sheep Ranch Water Association's (Old Sheep Ranch or Association) application requesting to establish rates be suspended for six months effective July 1, 2008.

DISCUSSION:

Old Sheep Ranch Water Association is located in the vicinity of Langlois, Oregon, and provides water service to 33 members¹ of the Association.

On December 3, 2007, the Commission received petitions from around 30 percent of the membership, exceeding the statutory threshold of 20 percent. Therefore, pursuant to ORS 757.063, Old Sheep Ranch met the requirement for Commission regulation.

On January 27, 2008, the Commission issued Order No. 08-111 (WJ 17) asserting jurisdiction over Old Sheep Ranch and ordering the Association to file tariffs with the Commission.

On May 16, 2008, Old Sheep Ranch complied with Order No. 08-111 by filing, an application to establish rates resulting in total annual revenues of \$11,880, an \$883

decrease from 2007 annual revenues reported by the previous Board of Directors.² According to the application, even though Old Sheep Ranch proposes a slight rate decrease in revenues, the Association proposes that rates remain the same.³

In the application, Old Sheep Ranch requests zero percent rate of return on rate base because the Association is a domestic nonprofit mutual benefit corporation with members.

Even though Old Sheep Ranch is requesting a slight decrease in annual revenue, this is the first rate case for the Association, and Staff needs adequate time to complete its normal investigation of the revenues, expenses, plant rate base, and rate design.

PROPOSED COMMISSION MOTION:

Pursuant to ORS 757.215, the proposed tariffs filed by Old Sheep Ranch Water Association be suspended for six months, effective July 1, 2008.
