**DISPOSITION: REGULATION WITHDRAWN**

Until July 9, 2008, BLUEGRASS PARK WATER COMPANY INC (Bluegrass Park or Company) was a privately-owned public utility providing service to approximately 30 residential customers in Grants Pass, Oregon. As a regulated public utility, the Company was subject to the Public Utility Commission’s (Commission) Annual Revenue Fee pursuant to ORS 756.310.

On July 14, 2008, the Commission received Bluegrass Park’s 2007 Annual Revenue Fee Statement along with a note stating that the City of Grants Pass had acquired the water system.

On July 15, 2008, Commission Staff contacted Pam Buckley in the City of Grants Pass Community Development division. Ms. Buckley confirmed that the City of Grants Pass began providing water service to Bluegrass Park’s customers on July 9, 2008.

Because the City of Grants Pass now serves the customers previously served by Bluegrass Park, the Company is no longer a public utility as defined in ORS 757.005.

**FINDINGS OF FACT**

Based on the information provided by the Company and the City of Grants Pass, Bluegrass Park Water Company Inc no longer provides water service to or for the public.

The City of Grants Pass now serves customers formerly served by Bluegrass Park Water Company Inc.

Bluegrass Park Water Company Inc provided water service during 2008 and is subject to the Commission's annual fee for the year ending December 31, 2008.

**CONCLUSIONS OF LAW**

Bluegrass Park Water Company Inc no longer provides water service to or for the public.

According to the definition in ORS 757.005, Bluegrass Park Water Company Inc is no longer a public utility subject to Commission regulation for purposes of ORS Chapter 757.

**ORDER**

IT IS ORDERED that:

1. Bluegrass Park Water Company Inc is no longer a public utility for purposes of ORS Chapter 757.
2. Bluegrass Park Water Company Inc is subject to the Commission's Annual Fee for the year ending December 31, 2008.
3. The Company is not subject to the Commission's Annual Fee after the year ending December 31, 2008.
