## DISPOSITION: APPLICATION APPROVED

## STAFF RECOMMENDATION:

Staff recommends approval of Portland General Electric's (PGE or Company) request in Docket UM 1301(2) to defer its 2009 Quarterly Direct Access Open Enrollment Costs/Benefits, effective February 1, 2009, through January 31, 2010. Any ratemaking treatment for deferred amounts should be reserved for a ratemaking proceeding.

#### **DISCUSSION:**

#### **Deferral History**

Quarterly Direct Access (QDA) enrollment windows were adopted by the Commission in Order No. 06-528. At that time, PGE and parties entered into, and the Commission approved a stipulation by which eligible customers on a cost-of-service rate schedule will be provided an opportunity to move to direct access service or an applicable noncost of service pricing option. For those customers electing to move from the cost-ofservice option, PGE will defer the difference between the value of the energy based on (1) the forward curves used to establish the Annual Transition Adjustment rates and (2) the actual sale of power by PGE's Power Operations Group, if such amounts exceed \$60,000 on a quarterly basis, as specified in PGE's Schedule 128.

PGE filed tariff Schedule No. 128 pursuant to the Stipulation and in compliance with Commission Order No. 07-015, on January 16, 2007. This schedule provides for windows in addition to the annual November election window PGE offered in the past.

An election to move to QDA by an eligible customer will apply for the balance of the calendar year. Each QDA open enrollment window will be open for not less than three full business days following the posting of the applicable transition adjustment rates.

On December 12, 2007, PGE filed an application requesting authorization to defer costs/benefits related to its November 2007 Annual Direct Access Open Enrollment Window (Docket No. UM 1359). Per Staff's request, PGE withdrew this filing, effective March 17, 2008. Staff and the Company agreed that the costs/benefits associated with the November window were appropriately treated under the provisions of the UM 1301 deferral.

In Order 07-108 (Docket No. UM 1301), the Commission authorized PGE to defer the QDA Open Enrollment costs and benefits for the period February 1, 2007, through January 31, 2008. The Commission approved the Company's request for reauthorization to defer costs/benefits on a quarterly basis for the period February 1, 2008, through January 1, 2009, in Order 08-153 (Docket No. UM 1301(1)).

#### Application for Deferral

On January 23, 2009, PGE filed an application requesting reauthorization to defer QDA Open Enrollment costs/benefits from February 1, 2009, through January 31, 2010.

This deferral provides a mechanism for PGE to track the cost or benefit of open enrollment options and defer those costs or benefits for later ratemaking treatment pursuant to ORS 757.259(2)(e). The deferral of such costs or benefits will minimize the frequency of rate changes or fluctuations and match appropriately the costs borne by and benefits received by customers.

The amount to be deferred could be a credit or a charge to customers depending upon the actual wholesale power prices at the time PGE disposes of any surplus power resulting from customer elections. PGE proposes to record the deferral as a regulatory asset in FERC Account 182.3 (Other Regulatory Assets) with an offsetting credit to FERC Account 447 (Sales for Resale).

Since the deferred amount is a function of changes in the wholesale market prices and the amount of customer load that moves, a precise amount of the deferral is not known. PGE requests that interest will accrue at its authorized cost of capital, currently 8.334%.

Staff has reviewed the application and finds that PGE's request is reasonable. Staff recommends that the ratemaking treatment for such costs or benefits be reserved for a subsequent ratemaking proceeding.

#### **PROPOSED COMMISSION MOTION:**

PGE's request in Docket UM 1301(2) to defer its 2009 QDA Open Enrollment Costs/Benefits, be approved effective February 1, 2009, through January 31, 2010. Any ratemaking treatment for deferred amounts should be reserved for a ratemaking proceeding.
