DISPOSITION: PORTFOLIO COMMITTEE RECOMMENDATIONS APPROVED

STAFF RECOMMENDATION:

The Portfolio Options Committee (the Committee) recommends that the Commission appoint the following individuals to serve on the Committee for the remainder of the November 2008 to October 2010 term, replacing departing members:

To represent the Renewable Northwest Project: Suzanne Leta Liou

The Committee recommends that the following individuals be appointed as proxies for Committee members:

• Diane Zipper for Suzanne Leta Liou, Renewable Northwest Project

DISCUSSION:

The Committee recommends electric portfolio product and pricing options to the Commission, pursuant to OAR 860-038-0220. OAR 860-038-0005(2) specifies that the Committee be composed of representatives of the Commission staff, Oregon Department of Energy, the electric companies, residential and small nonresidential customers, local governments, and public or regional interest groups.

The rules do not specify the number of representatives from each category that may serve on the committee. However, the Committee has tried to maintain at least two representatives each for residential customers, small nonresidential customers, public/regional interest groups and local governments, in addition to one representative from each of the utilities, Commission staff, and the Oregon Department of Energy.

As members or proxies become unavailable for a current term, the Committee makes recommendations for their replacement. The list of committee members and proxies for the current term (November 2008 to October 2010) is included as Attachment A. Katie Kalinowski of Renewable Northwest Project is no longer available to complete her term.

At the September 11, 2009 meeting of the Portfolio Options Committee, it was unanimously recommended that the Commission be asked to appoint the following individuals to the Committee:

Proposed Representatives - New members

Suzanne Leta Liou is a senior Policy Advocate for the Renewable Northwest Project, representing RNP on the Energy Trust of Oregon's Renewable Advisory committee and serves as a member of Governor Kulongoski's Renewable Energy Group. Suzanne has served as proxy on the Portfolio Options Committee since February 2009.

Recommended Proxies

At its public meeting on July 12, 2005, the Commission adopted the Committee's recommendation for an operational policy related to proxies for committee members. The policy states in part, "A Portfolio Options Committee member may name a proxy for approval by the Commission. A 'named' proxy will be allowed to vote on behalf of a Committee member in that member's absence." Staff recommends the Commission approve the following proxies named by Committee members:

Diane Zipper has worked for the Renewable Northwest Project since 1998. The focus of her work has largely been outreach and education on renewable energy and the available green power options, along with policy issues surrounding green power purchasing and pricing programs. Ms. Zipper has been actively engaged in PGE and Pacific Power renewable energy programs and served on the POC as either a member or proxy through much of that time. Suzanne Leta Liou requests that Ms. Zipper serve as her proxy, representing Renewable Northwest Project.

The Committee is currently reviewing potential nominees for the open position representing public/regional interest groups and is awaiting identification of a proxy representative for the Association of Oregon Counties.
