ORDER

**DISPOSITION: PROPOSED BUDGETS FOR ISSUE FUND
GRANTS APPROVED**

On May 18, 2010, the Citizens' Utility Board of Oregon (CUB) and the Industrial Customers of Northwest Utilities (ICNU) filed proposed budgets for Issue Fund Grants in this proceeding. CUB's proposed budget shows eligible expenses in the amount of \$83,375; and it seeks an Issue Fund Grant in the amount of \$64,000. ICNU's proposed budget shows eligible expenses in the amount of \$141,020; and it seeks an Issue Fund Grant in the amount of \$64,000.

The First Amended and Restated Intervenor Funding Agreement (IFA), approved by the Commission in Order No. 07-564, provides that precertified intervenors must submit a proposed issue fund budget to the Commission that contains, at a minimum, the following information:

- 1) A statement of the work to be performed;
- 2) A description of the areas to be investigated;
- 3) A description of the particular customer class(es) that will benefit from the intervenor's participation;
- 4) Identification of the specific fund accounts from which the intervenor is seeking monies and an estimate of the amount of available funds in that account;
- 5) A budget showing estimated attorney, consultant and expert witness fees, which may include the cost for appropriate support staff and operations support; and
- 6) A representation that the intervenor will use matching funds in the form of either in-house resources or outside funding to account for or pay at least

20 percent of the eligible expenses for which the intervenor is seeking an Issue Fund Grant.

Once a proposed budget is received, we decide whether Issue Fund Grants are available for use based on factors identified in the IFA. We have the authority to accept, deny or partially deny the request, and may place reasonable conditions on the grant.

CUB was automatically precertified to receive Issue Fund Grants under Section 5.2(a) of the IFA and OAR 860-012-0100(3)(a). ICNU became precertified on August 21, 2003, in Order No. 03-502. The proposed budget filings of CUB and ICNU include the requisite information and reflect the current schedule adopted in this docket.


In light of the issues being addressed, the complexity of the issues and the significant policy decisions to be made, we believe that the proposed budgets of CUB and ICNU are reasonable and should be approved. We further note that granting these proposed budget requests leaves an available balance of less than \$200 in Portland General Electric Company's Issue Fund.

ORDER

IT IS ORDERED that:

1. The Citizens' Utility Board of Oregon's proposed budget for an Issue Fund Grant is approved, and an Issue Fund Grant is approved for CUB up to \$64,000.
2. The Industrial Customers of Northwest Utilities' proposed budget for an Issue Fund Grant is approved, and an Issue Fund Grant is approved for ICNU up to \$64,000.
