SUBJECT: PACIFIC POWER & LIGHT: (Docket No. UM 1363(2)) Reauthorization of deferred accounting related to the costs for the independent evaluators for the solicitation process established in Docket UM 1360 for flexible resources beginning 2012 through 2017.

STAFF RECOMMENDATION:

I recommend that Pacific Power & Light's application be approved.

DISCUSSION:

In this filing Pacific Power & Light (PPL or Company) requests reauthorization to defer the costs related to Commission-selected independent evaluators (IE)¹ as previously granted in Docket UM 1363 by Commission Order Nos. 08-119 and 09-071.2 This deferral was established in accordance with the competitive bidding guidelines associated with the acquisition of resources established in Docket No.UM 1182 by Order No. 06-446. PPL's filing meets the requirements of ORS 757.259 and OAR 860-027-0300(3).

Reasons for Deferral

The IE continue to perform services under their respective IE contracts and will continue to do so until the conclusion of the process established in UM 1360. ORS 757.259(2)(e) allows utility expenses or revenues to be deferred where necessary to appropriately match the costs borne by and benefits received by customers and to minimize the frequency of rate changes or fluctuation of rate levels. Because a deferral period may

not exceed twelve months beginning on or after the date of application, the Company seeks an order reauthorizing deferral of these costs from the date of its application through April 20, 2011.

Proposed Accounting

PPL proposes the deferrals be recorded in Account 182.3, Other Regulatory Assets, consistent with the Company's current deferral accounting practices under the previously approved IE deferred accounting orders.

Estimated Deferral in Authorization Period

As of the date of this filing, PPL has paid the IE approximately \$380,000 for services. The Company estimates that the total cost of the IE services will be \$700,000.

PROPOSED COMMISSION MOTION:

PPL's application be approved for accounting purposes only.
