ORDER

DISPOSITION: ADVICE NO. 10-23 ALLOWED

On November 15, 2010, Portland General Electric Company (PGE) filed Advice No. 10-23 with the Public Utility Commission of Oregon (Commission), establishing the 2011 transition adjustment rates under Schedule 128. These transition adjustment rates would apply to eligible customers that elected to leave cost of service or chose direct access service starting January 1, 2011. A description of the filing and its procedural history is contained in the Staff Report, attached as Appendix A, and incorporated by reference.

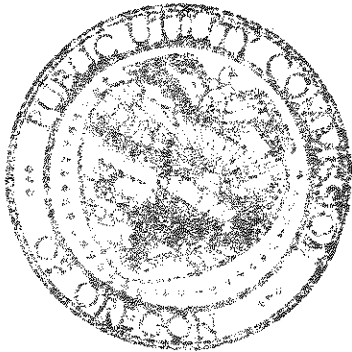
At its public meeting on December 28, 2010, the Commission adopted Staff's recommendation, and allowed the Company's Advice No. 10-23 to go into effect.

SUBJECT: PORTLAND GENERAL ELECTRIC: (Docket No. UE 215/Advice No. 10-23) Revises Schedule 128 to reflect the final Docket UE 215 Net Variable Power Costs update for 2011.

STAFF RECOMMENDATION:

Staff recommends that Portland General Electric's (PGE or company) Advice No. 10-23 revising Schedule 128 Annual Short Term Transition Adjustment rates to reflect the final net variable power cost update for 2011 be approved effective January 1, 2011.

DISCUSSION:

On November 15, 2010, PGE filed Advice No. 10-23 establishing the 2011 transition adjustment rates under Schedule 128. These transition adjustment rates would apply to eligible customers that elected to leave cost of service or chose direct access service starting January 1, 2011. The Schedule 128 transition adjustment rates incorporate the final Monet net variable power cost update and reflect the stipulations approved by the Commission in Order 10-478 in docket UE 215.

At the time these rates were filed with the Commission, they were also posted on the Company website. The posting enabled nonresidential customers to factor these annual transition rates for 2011 into their direct access decision-making during the election window that lasted from November 15 to November 22, 2010.

The transition adjustment rates reflect the difference between tariff energy charges under the cost of service option, including Schedule 125, and the projected market price

of power applied to the load shape of each applicable schedule. PGE's proposed rates comply with the calculation methodologies adopted in Commission Order 06-528.

PROPOSED COMMISSION MOTION:

PGE's Advice No. 10-23 be allowed to go into effect on January 1, 2011.
