ORDER

Application for Approval of Merger between CenturyTel, Inc., and Qwest Communications International, Inc.

DISPOSITION: PARTIAL WAIVER OF CONDITION GRANTED

I. SUMMARY

In this Order, the Public Utility Commission of Oregon (Commission) waives certain notification provisions of Condition 5 in Appendix A of Order No. 11-095, entered March 24, 2011 (the Merger Order)¹.

II. BACKGROUND

The Commission's Merger Order granting CenturyLink, Inc.'s application for an Order to Approve the Indirect Transfer of Control of Qwest Corporation (Qwest), included a list of conditions set forth in its Appendix A. Condition 5 in the Appendix reads as follows:

Prior to the closing of the transaction, customer notification of the merger and change of parent company will be given to all local exchange and long distance customers and will comply with any state and FCC rules and regulations. This notice will include notification to all existing and acquired OTAP/Lifeline customers that the acquisition will not affect their OTAP/Lifeline credits and that there is no action required on their part. Prior to the notification, CenturyLink will submit a draft of the OTAP/Lifeline portion to the OTAP Manager for review.

The Merger Transaction closed eight days later, on April 1, 2011. On March 31, 2011, CenturyLink, Inc. (CenturyLink or Applicant) filed a request (Request)

seeking a partial waiver of Condition 5. In that Request, Applicant stated that it had submitted a draft of the notification to the Commission's OTAP Manager for review and input as specified in the Condition. "However, due to the short window of time between the Order (March 24) and the merger closing date (April 1), CenturyLink and Qwest were not able to begin noticing customers. CenturyLink and Qwest will notice customers in the first bill cycle beginning April 1, 2011, and continuing through the month." (Request at 2).

III. DISCUSSION

We find that the Applicant has shown good cause for a waiver of the notification requirements to the extent necessary so that all affected customers receive the condition-specified notification with their bills, beginning April 1, 2011.

IV. ORDER

The request of CenturyLink, Inc., for a partial waiver of Condition 5 in Appendix A to Order No. 11-095, consistent with the conditions set forth above, is Granted.
