Request for Order to Sign Proposed Bonneville Power Administration Residential Exchange Program Settlement Agreement and the Residential Exchange Program Settlement Implementation Agreement.

DISPOSITION: REQUEST APPROVED

On March 22, 2011, Portland General Electric Company (PGE), filed a request with the Public Utility Commission of Oregon (Commission), asking that the Commission require it to sign the Residential Exchange Program Settlement Agreement and the Residential Exchange Program Settlement Implementation Agreement offered by the Bonneville Power Administration (BPA). Details of the Settlement Agreements may be found in the Staff Report for Agenda Item No. 1 of the April 5, 2011 Public Meeting available on the Commission's website.

PGE seeks authorization to execute the Settlement Agreements. PGE concludes that the risks of signing the agreement are outweighed by its benefits.

Staff's recommendation and further description of the procedural history of the Settlement Agreement is contained in the Staff Report, attached as Appendix A and incorporated by reference.

At its Public Meeting on April 5, 2011, the Commission adopted Staff's recommendation that the Commission issue an order directing PGE to execute the Settlement Agreements.

IT IS ORDERED that Portland General Electric Company shall execute the proposed Bonneville Power Administration Residential Exchange Program Settlement Agreement, and if offered by the Bonneville Power Administration, the Residential Exchange Program Settlement Implementation Agreement.

STAFF RECOMMENDATION:

I recommend that the Commission require Portland General Electric (PGE) to execute the proposed Bonneville Power Administration (BPA) Residential Exchange Program Settlement Agreement and, if offered by BPA, the Residential Exchange Program Settlement Implementation Agreement.

DISCUSSION:

For a discussion of the background and issues, please refer to the Staff discussion contained in public meeting agenda item #1, "Execution of long-term settlement agreement resolving Residential Exchange Program issues."

I agree with PGE's assessment of risks and benefits outlined in its filing. As such, I support PGE's request to be directed to execute the Residential Exchange Program Settlement Agreement, and if offered by BPA, the Residential Exchange Program Settlement Implementation Agreement.

In addition, I should note that PGE's current Residential Exchange Program (REP) contract with BPA expires on September 30, 2011. In the event the Settlement Agreement does not become effective, either by the failure of the publicly-owned utilities to produce a sufficient number of signers, or because it is not approved by BPA, then PGE will need to negotiate with BPA (and OPUC Staff) an alternative REP mechanism, obtain Commission approval to execute the alternative agreement, and execute it prior to October 1, 2011.

PGE estimates that the residential and small farm benefits will increase beginning on October 1, 2011, from \$49 million to \$58 million annually. This is due principally to the fact that PGE's Average System Cost for BPA FY 2012 has increased more relative to those of the other IOUs. The increase in REP benefits translates to a rate reduction of approximately 1%. The likely timing of the retail rate change that would incorporate the higher level of REP benefits is January 1, 2012, a date on which other rate changes, (e.g., those associated with PGE's Power Cost Adjustment Mechanism), are expected to occur.

Finally I would like to note my appreciation for the roles played by the PGE representatives in the mediation. Jim Lobdell did an excellent job focusing the IOU Group's discussions. And, on many occasions Mr. Lobdell was asked to speak on behalf of the IOU Group and represented our group well in all aspects. Stefan Brown spent countless hours on technical analysis to assist the IOU Group in understanding the ramifications of different proposals. The legal expertise brought by PGE counsel Cheryl Chevis was also extremely valuable to the group, as were David White's efforts in drafting the Settlement Agreement.
