DISPOSITION: STIPULATION ADOPTED

On August 23, 2011, the Public Utility Commission of Oregon filed a complaint against Defendant. The complaint charged Defendant with two violations of law, OAR 952-001-0070, and requested a penalty of \$10,000. On August 23, 2011, a copy of the complaint was served.

On September 20, 2011, the parties to this proceeding entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, Defendant admits that the violations were committed as alleged in the Complaint and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant contends that the violations were the result of actions by a third party contractor, but accepts responsibility for payment of the fines as an operator subject to OAR 952-001-0070.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and Defendant has violated Oregon Administrative Rule(s) as alleged. Pursuant to the provisions of ORS 757.993, penalties should be assessed against Defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Qwest Corporation, (a Colorado corporation), dba CenturyLink in the amount of \$10,000 for two violations of law.
- 3. Defendant shall pay the sum of \$10,000, due and payable within 30 days from the date of entry of this order. Payment shall be by money order or check made out to the **Public Utility Commission of Oregon**, and the memo line of the money order or company check shall state the "NC" docket number in the caption of this order. (Mail payment to: Public Utility Commission of Oregon, PO Box 2153, Salem, OR 97308.)
