On October 6, 2011, Northwest Natural Gas Company, dba NW Natural, requested approval for exclusion from B-1 Service Quality Measure for Billing Accuracy (B-1 SQM) for the bill message redesign project, scheduled to begin November 5, 2011. A description of the filing and its procedural history is contained in the Staff Report, attached as Appendix A, and incorporated by reference.

At its Public Meeting on November 1, 2011, the Commission adopted Staff's recommendation.

ORDER

IT IS ORDERED that Northwest Natural Gas Company's request for exclusion is approved with the following conditions:

- 1. A billing error that does not meet the definition of B-1 Service Quality Measure will be subject to the C-1 Service Quality Measure requirements that currently apply to NW Natural.
- 2. To be eligible for the exclusion from the B-1 Service Quality Measure requirement, a billing error must have directly resulted from the bill message redesign project.

STAFF RECOMMENDATION:

Staff recommends that Northwest Natural's (NWN or Company) request for exclusion be approved with the following conditions:

1. A billing error that does not meet the definition of B-1 Service Quality Measure will be subject to the C-1 Service Quality Measure requirements that currently apply to NWN.

2. To be eligible for exclusion from the B-1 SQM requirement, a billing error must have directly resulted from the bill message redesign project.

DISCUSSION:

NWN requests approval for exclusion from the B1 Service Quality Measure for Billing Accuracy (B1 SQM) for the bill message redesign project, scheduled to begin on November 5, 2011. In the Company's original filing, the exclusion period requested was from October 31, 2011, through February 1, 2012. This request could not go before the Commission until, November 1, 2011. For this reason, NWN delayed the launch of its project until November 5, 2011. The exclusion period will now be November 5, 2011, through February 4, 2012.

NWN states, that the bill message redesign project will simplify the bill message programming code to add more flexibility and efficiency to the bill message process.

Currently, bill messages are generated with hard code programming in the bill select, bill calculation and bill print programs. This project involves replacing the hard code process with a control file process. The use of control files will allow bill messages to be generated more efficiently, and changes or additions to the bill message library to occur more quickly.

NWN has identified a thirteen month transition period, with regard to viewing historical bill statements online in HTML format, as a result of this bill message redesign project. A customer who wants to view a historical bill including the correct bill messages will be able to do so if they choose the "pdf" view. The Company retains thirteen months of historical bills on its website. During this period, the Company will display a message¹ on such historical bills until all historical bills issued under the old code have cycled through.

Exclusions were previously granted during implementation of both phases of NWN's Automated Meter Installation Project and for its On-the-Bill Repayment Service. Staff believes the ninety day exclusion from the B-1 SQM requirements for the bill message redesign project is reasonable.

PROPOSED COMMISSION MOTION:

NWNs filing to request an exclusion period from the B1 SQM requirements be approved subject to the following conditions:

1. A billing error that does not meet the definition of B-1 Service Quality Measure will be subject to the C-1 Service Quality Measure requirements that currently apply to NWN.

2. To be eligible for exclusion from the B-1 SQM requirement, a billing error must have directly resulted from the bill message redesign project.
