DISPOSITION: STIPULATION ADOPTED

On January 13, 2012, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0050, and requested a penalty of \$1,000. On January 13, 2012, a copy of the complaint was served.

On February 20, 2012, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties.

The parties further agree that a portion of the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of two years following the date of the Commission's final order in these proceedings.

The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rules as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

ORDER

IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against Dan Kauffman Excavating, Inc.. (an Oregon corporation), in the amount of \$1,000 for one violation of law.
- 3. Defendant shall pay the sum of \$200, due and payable within 30 days from the date of service of this order. The Commission acknowledges receipt of the amount of \$200 from defendant on February 28, 2012.
- 4. Payment of the balance of the penalties (\$800) shall be suspended, unless:
 - Defendant fails to comply with paragraph 3 above; or (a)
 - A showing is made that defendant has violated, within two years of the (b) date of this order, any rules administered by the Oregon Utility Notification Center.
- 5. If defendant has not paid the amount assessed in paragraph 3 above within 30 days from the date of service of this order, the unpaid balance of the amount assessed in paragraph 2 shall be due immediately following the expiration of that time period.

5	A.	Defendant shall sign and return this stipulation within 20 days of the date it was served

7	B.	\$200 shall become due and payable on or before the 30th day following the
8		Commission's entry of a final order in this case.
9	C.	Payment shall be by <u>money order</u> made out to the <u>Public Utility Commission of</u>
10		Oregon, and the memo line of the money order shall state the "NC" docket number in the
11		caption of this stipulation.
12	D.	Payment of the balance of the penalties (\$800) shall be permanently suspended and no
13		further penalties shall be imposed for the violation alleged in the Complaint unless
14		defendant fails to comply with all of the terms of this stipulation and all of the rules
15		adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for a two
16		year period following the date of the Commission's entry of a final order.
17	E.	In the event that complainant contends that the defendant has not complied with all of the
18		terms of this stipulation and all OUNC rules for that two year period, complainant may
19		reopen this proceeding and petition for imposition of all or a portion of the suspended
20		penalties. In such case defendant shall be entitled to a hearing and to be notified of the
21		basis upon which complainant contends that compliance has not occurred.
