**STAFF RECOMMENDATION:**

Staff recommends that the Commission approve Pacific Power's Request for Proposals (RFP) for Retail Marketing Services and Renewable Energy Certificates for Two Oregon Voluntary Renewable Energy Options, Renewable Usage and Habitat.

**DISCUSSION:**

On May 10, 2012, Pacific Power filed its proposed RFP for Retail Marketing Services and Renewable Energy Certificates for Two Oregon Voluntary Renewable Energy Options, Renewable Usage and Habitat. The RFP is requesting bids for retail marketing services and renewable energy certificates for the Company's Renewable Usage Supply Service in Schedule 211 and the Habitat Supply Service in Schedule 213 for the period of January 1, 2013, to December 31, 2015.

This RFP for marketing services and renewable energy certificates is a continuation of the regular process initiated in 2001. The RFP process was initially established in Order No. 01-470. The first RFP for marketing services and renewable energy certificates was approved in Order No. 01-745. RFPs were also approved in 2003, 2006, and 2009.

The draft RFP was discussed at the Portfolio Options Committee (POC) meeting on May 8, 2012, at which the POC supported approval of the RFP. One edit was proposed by Commission Staff, which has been incorporated into the final draft RFP in this filing.
