#### DISPOSITION: STIPULATION ADOPTED

On May 16, 2012, the Public Utility Commission of Oregon filed a complaint against defendant. The complaint charged defendant with one violation of law, OAR 952-001-0050, and requested a penalty of \$1,000. On May 22, 2012, a copy of the complaint was served.

On July 24, 2012, a Pipeline Safety Utility Analyst called defendant. Based on that conversation, a duplicate original Stipulation was mailed to defendant on July 26, 2012.

On August 10, 2012, the parties in these proceedings entered into a stipulation, which is attached as Appendix A.

Under the terms of the stipulation, defendant admits committing the alleged violation and agrees that the Commission may enter an order assessing civil monetary penalties. Defendant also agrees to complete, within 45 days following the entry of a final order, a training session with the Oregon Utility Notification Center Speakers Bureau on Oregon excavation laws.

The parties further agree that a portion of the penalties should be suspended, unless defendant fails to comply with any provision of the stipulation or violates any rule adopted by the Oregon Utility Notification Center under ORS 757.552 for a period of one year following the date of the Commission's final order in these proceedings.


The stipulation is adopted. From the foregoing, it is concluded that no hearing is required. Under the terms of the stipulation, the allegations of the complaint are true, and defendant has violated Oregon Administrative Rule as alleged. Under the provisions of ORS 757.993, penalties should be assessed against defendant under the terms and conditions of the stipulation.

#### ORDER

#### IT IS ORDERED that:

- 1. The stipulation, attached as Appendix A, is adopted.
- 2. Civil monetary penalties shall be assessed against B. Gentle Concrete Construction Co., (an Oregon corporation), in the amount of \$1,000 for one violation of law.
- 3. Defendant shall pay the sum of \$200, due and payable within 30 days from the date of service of this order. Payment shall be by <u>cashier's check</u> or money order made out to the **Public Utility Commission of Oregon**, and the <u>memo line of the cashier's check or money order shall state the</u> <u>"NC" docket number</u> in the caption of this order. (Mail payment to: Public Utility Commission of Oregon, PO Box 2153, Salem, OR 97308.)
- 4. Payment of the balance of the penalties (\$800) shall be suspended, unless:
  - (a) Defendant fails to comply with paragraph 3 above; or
  - (b) A showing is made that defendant has violated, within one year of the date of this order, any rules administered by the Oregon Utility Notification Center; or
  - (c) Defendant fails to timely complete a training session with the Oregon Utility Notification Center Speakers Bureau. Defendant shall contact the OUNC Speakers Bureau to arrange for, and attend a training session on Oregon excavation laws within 45 days of the entry of this order.

5. If defendant has not paid the amount assessed in paragraph 3 above within 30 days from the date of service of this order, or has not timely completed a training session on Oregon excavation laws within 45 days of the entry of this order, the unpaid balance of the amount assessed in paragraph 2 shall be due immediately following the expiration of either time period.



A party may request rehearing or reconsideration of this order under ORS 756.561. A request for rehearing or reconsideration must be filed with the Commission within 60 days of the date of service of this order. The request must comply with the requirements in OAR 860-001-0720. A copy of the request must also be served on each party to the proceedings as provided in OAR 860-001-0180(2). A party may appeal this order by filing a petition for review with the Court of Appeals in compliance with ORS 183.480 through 183.484.

2	The parties further agree that the Commission may enter an order assessing civil	
3	monetary penalties against Defendant in the amount of \$1,000 under the following terms and	
4	conditions:	
5	A. Defendant must sign and return this Stipulation within 20 days of the date it was	
6	served upon (mailed to) defendant.	
7	B. \$200 becomes due and payable on or before the 30 <sup>th</sup> day following the Commission's	
8	entry of its order in this case.	
9	C. Payment must be by <u>money order</u> made out to the <u>Public Utility Commission of</u>	
10	Oregon, and the memo line of the money order must state the "NC" docket number	
11	in the caption of this Stipulation.	
12	D. Payment of the balance of the penalties (\$800) will be permanently suspended and no	
13	further penalties will be imposed for the violation alleged in the Complaint unless	
14	. Defendant fails to comply with all of the terms of this stipulation and all of the rules	
15	adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for a	
16	one-year period following the date of the Commission's entry of an order.	
17	E. Defendant must contact the OUNC Speakers Bureau online at	
18	www.digsafelyoregon.com or by calling (503) 232-1987 to arrange for and attend a	
19	training session on Oregon excavation laws within 45 days following the entry of the	
20	Commission's order.	
21	F. In the event that Complainant contends that Defendant has not complied with all of	
22	the terms of this Stipulation and all OUNC rules for that one-year period,	
23	Complainant may reopen this proceeding and petition for imposition of all or a	
24	portion of the suspended penalties. In such case, Defendant is entitled to a hearing	
25	and to be notified of the basis upon which Complainant contends that compliance has	
26	not occurred.
