**ORDER** 

## DISPOSITION: CERTIFICATE OF AUTHORITY CANCELED

On October 15, 2010, Business Coverage Centre LLC was granted a certificate of authority to provide telecommunications service in Oregon as a competitive provider. *See* Order No. 10-398.

Business Coverage Centre LLC has failed to collect and remit monthly Residential Service Protection Fund (RSPF) surcharges to the Commission or complete a Surcharge Exception Form to comply with RSPF requirements pursuant to ORS 290, Section 7, Oregon Laws 1987, and OAR 860-033-0006.

On May 7, 2012, the Commission notified the certificate holder that the report had not been received. The certificate holder failed to respond.

ORS 756.515(4) provides that the Commission may, after investigation, but without hearing, make such findings and orders as deemed justified by the results of the investigation. In view of the foregoing, the Commission determined at its September 25, 2012, Public Meeting that the certificate holder has failed to comply with Commission rules and terms of the certificate. The certificate of authority to provide telecommunications service should be canceled, per OAR 860-032-0008(2). The company is reminded that because it had a certificate of authority for one or more days during 2012, it is required to file an annual fee statement and pay a minimum of \$100 for that year.

The Commission also concludes that it will not process a future application filed by the certificate holder for certification as a competitive provider, unless the certificate holder fully complies with Commission rules. Any future application must include:

1. Payment of all revenue fees, including all applicable late fees, owed for each calendar year of operation as a certified telecommunications provider pursuant to ORS 756.310(4)(a), in accordance with Commission requirements;

- 2. Confirmation of compliance with Oregon Universal Service Fund (OUSF) requirements pursuant to ORS 759.425 and OAR 860-032-0610 through 860-032-0660. All OUSF reports, contributions, late payment penalties, interest and late statement fees are due and owing for all quarters of operation, regardless of whether the telecommunications service provider held a certificate for the applicable period(s);
- 3. Annual reports for each calendar year of operation as a certified telecommunications provider pursuant to OAR 860-032-0060; and
- 4. Confirmation of compliance with Residential Service Protection Fund requirements pursuant to ORS 290, Section 7, Oregon Laws 1987, and OAR 860-033-0006.

If the certificate holder fails to include these items with its application, the Commission will deem the application incomplete and return it.

IT IS ORDERED that the certificate of authority held by Business Coverage Centre LLC is canceled.
